Ordinance No. 3088

AN ORDINANCE AMENDING TITLE 11, CHAPTER 54, SECTION 190 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, BY CLARIFYING THAT THE EXEMPTIONS GRANTED THEREIN APPLY ONLY TO A PERMITTEE ENGAGED IN FIELD WORK OR BUSINESS OUTSIDE OF THE OFFICE; IMPOSING AN APPLICATION FEE OF TWO DOLLARS (\$2.00); PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Removes potential abuse of parking exemption by restricting use of the permittees while actually engaged in field work or in business outside their office; also imposes two dollar (\$2.00) application fee.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Las Vegas Municipal Code Section 11.54.190
is hereby amended to read as follows:

11.54.190: (A) Parking exemption permits shall authorize the persons to whom they are issued to park, without violation, the vehicles to which the permits are affixed in any parking space adjacent to a street parking meter or in any space in a one-hour or two-hour time-limited parking zone, while actually engaged in field work, subject to the limitations in Subsection (C) of this Section.

(B) The following groups of persons shall be eligible for parking exemption permits upon application to the City Manager or his authorized designee:

(1) Members of news media whether involved in television, radio, or newspaper news preparation or reporting, who are actually in the field preparing or reporting news stories for their employers;

(2) Public officials and employees of Federal,

1 State, or local governments who are required
2 by their employers to use government-owned
3 or private automobiles [in discharge of their
4 job responsibilities or who regularly use
5 such vehicles in discharge of their job
6 responsibilities] while actually engaged in
7 field work or business outside of their
8 normal offices.

9 (C) No parking exemption permit shall be approved by
10 the City Manager under this Section unless he
11 receives a letter accompanying the application from
12 the applicant's supervisor describing such appli-
13 can'ts job responsibilities and his need for an
14 exempt parking permit and which shows to the City
15 Manager's satisfaction that the employee qualifies
16 for the permit.

17 (D) A fee of two dollars (\$2.00) shall be charged for
18 each parking exemption permit issued, the fee
19 shall accompany the parking permit request form.
20 If a parking exemption permit is denied, the money
21 shall be refunded.

22 (E) Once a parking exemption permit is issued to a
23 qualified applicant, it shall be unlawful for such
24 person to use permit for other than official
25 business, and in no case shall the permit authorize
26 any behicle to park in any space adjacent to a
27 street parking meter or in any space posted one
28 or two hour [in a] time-limited parking zone for
29 more than four hours continuously.

30 SECTION 2: If any section, subsection, subdivision,
31 paragraph, sentence, clause or phrase in this Chapter or any part
32 thereof, is for any reason held to be unconstitutional or invalid

1 or ineffective by any court of competent jurisdiction, such
2 decision shall not affect the validity or effectiveness of the
3 remaining portions of this Chapter or any part thereof. The City
4 Council of the City of Las Vegas, Nevada, hereby declares that it
5 would have passed each section, subsection, subdivision, paragraph,
6 sentence, clause or phrase thereof, irrespective of the fact that
7 any one or more sections, subsections, subdivisions, paragraphs,
8 sentences, clauses or phrases be declared unconstitutional,
9 invalid or ineffective.

10 SECTION 3: All ordinances or parts of ordinances,
11 sections, subsections, phrases, sentences, clauses or paragraphs
12 contained in the Municipal Code of the City of Las Vegas, Nevada,
13 1983 Edition, in conflict herewith are hereby repealed.
