HEREBY ORDAIN AS FOLLOWS:


SECTION 1: Chapter 6.78 of the Las Vegas Municipal

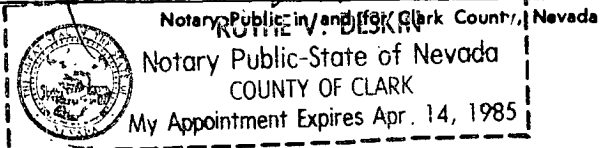
