ORDINANCE No. 3069

AN ORDINANCE RELATING TO PAWNBROKERS; CONFORMING THE RECORD KEEPING REQUIREMENTS OF EACH PAWN TRANSACTION AND THE RETENTION REQUIREMENTS OF EACH PAWNED ARTICLE TO STATE LAW; ESTABLISHING PENALTIES FOR VIOLATIONS THEREOF; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: LVMC 6.60.110 is hereby amended to read
as follows:

6.60.110: (A) Each pawnbroker [shall] must keep and maintain in his place of business a book in which shall be entered and legibly written in the English language, at the time of each pawn, an accurate record thereof containing:

(1) The date of the transaction;

(2) The name or other identification of the person or employee conducting the transaction;

(3) The name, age, street and house number, the serial number of one piece of positive identification or a work card issued pursuant to LVMC Chapter 6.86 and a general description of the [dress,] complexion, color of hair, and facial appearance of the person with whom the transaction is had[;]. In lieu of recording the serial number of a piece of positive identification or a work card, the record may contain an indication that the pawnbroker knows the person with whom the transaction is had;

(4) [The name, street and house number of the owner of the property received in pawn;

(5) The street and house number of the place from which the property pawned was last removed;

(6)] A description of the property pawned. In the case of watches, the description [shall] must contain the name of the

1 maker and the number of [both] the works [and] or the case. In
2 the case of jewelry, all letters and marks inscribed thereon
3 [shall] must be included in the description;

4 [(7)] (5) The amount loaned;

5 [(8) The names, streets and house numbers of all persons wit-
6 nessing the transaction;

7 (9)] (6) The number of the pawn receipt issued therefor.

8 (B) The record and all goods received [shall] must at all
9 times during the ordinary hours of business be open to inspection
10 by the Metropolitan Police Department.

11 SECTION 2: LVMC 6.60.200 is hereby amended to read
12 as follows:

13 6.60.200: No property received in pawn by any pawnbroker
14 [shall] may be removed from his place of business, except when
15 redeemed by the pawnor, until the expiration of [four] ten days
16 after the receipt thereof has been reported to the Metropolitan
17 Police Department as required by Section 6.60.140.

18 SECTION 3: There is hereby added to the LVMC a new
19 section 6.60.250 which is to read as follows:

20 6.60.250: It is unlawful for any pawnbroker, or any clerk,
21 agent or employee of a pawnbroker to:

22 1. Fail to make an entry of any material matter in his book
23 or record kept as provided for in LVMC 6.60.110.

24 2. Make any false entry in his book or record.

25 3. Obliterate, destroy or remove from his place of business
26 the book or record.

27 4. Refuse to allow inspection by the Las Vegas Metropolitan
28 Police Department of the book or record or any goods in his
29 possession, during the ordinary hours of business.

30 5. Report any material matter falsely to the Las Vegas
31 Metropolitan Police Department.

32 6. Fail to report forthwith to the Las Vegas Metropolitan

1 Police Department possession of any property which he may have
2 good cause to believe has been lost or stolen, together with the
3 name of the owner, if known, and the date when and the name of
4 the person from whom he received the property.

5 7. Remove or allow to be removed from his place of busi-
6 ness, except upon redemption by the owner thereof, any property
7 received within 10 days after the receipt thereof is reported to
8 the Las Vegas Metropolitan Police Department.

9 8. Receive any property from any person under the age of 18
10 years, any common drunkard, any habitual user of controlled
11 substances as defined in Chapter 453 of NRS, any habitual crimi-
12 nal, any person in an intoxicated condition, any known thief or
13 receiver of stolen property, or any known associate of a thief or
14 receiver of stolen property, whether the person is acting in his
15 own behalf or as the agent of another.

16 9. Violate the provisions of LVMC 6.60.080 or
17 LVMC 6.60.120.

18 SECTION 4: LVMC 6.60.180 is hereby repealed.

19 SECTION 5: If any section, subsection, subdivision,
20 paragraph, sentence, clause or phrase in this Chapter or any part
21 thereof, is for any reason held to be unconstitutional or invalid
22 or ineffective by any court of competent jurisdiction, such deci-
23 sion shall not affect the validity or effectiveness of the
24 remaining portions of this Chapter or any part thereof. The City
25 Council of the City of Las Vegas hereby declares that it would
26 have passed each section, subsection, subdivision, paragraph,
27 sentence, clause or phrase thereof irrespective of the fact that
28 any one or more sections, subsections, subdivisions, paragraphs,
29 sentences, clauses or phrases be declared unconstitutional,
30 invalid or ineffective.

31 SECTION 6: Whenever in this ordinance any act is
32 prohibited or is made or declared to be unlawful or an offense or

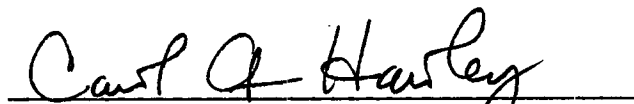
1 a misdemeanor, or whenever in this ordinance the doing of any act
2 is required or the failure to do any act is made or declared to
3 be unlawful or an offense or a misdemeanor, the doing of any such
4 prohibited act or the failure to do any such required act shall
5 constitute a misdemeanor and upon conviction thereof, shall be
6 punished by a fine of not more than \$1,000.00 or by imprisonment
7 for a term of not more than six (6) months, or by any combination
8 of such fine and imprisonment. Any day of any violation of this
9 ordinance shall constitute a separate offense.

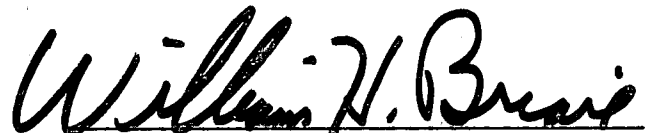

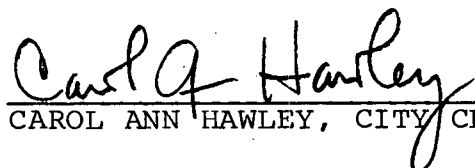
