

ORDINANCE NO. 934-147

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-T and R-3 to C-1 (Z-76-65)

A portion of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of Section 22, Township 20 South, Range 61 East, MDB&M, and more particularly described as follows:

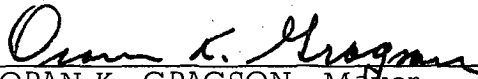
Commencing at the Southwest corner of said Section 22, thence North 01°24'55" East a distance of 50.0 feet to the true point of beginning; thence South 89°51'05" East a distance of 502.50 feet to a point; thence North 02°07'36" West a distance of 165.5 feet to a point; thence South 87°52'24" West a distance of 376.3 feet to a point; thence North 02°07'36" West a distance of 950.0 feet to a point; thence South 87°52'24" West a distance of 48.58 feet to a point; thence along a curve concave to the left, subtending a central angle of 93°32'31" with a radius of 10.0 feet, and an arc length of 16.33 feet to a point; thence South 01°24'55" West a distance of 1087.99 feet to the true point of beginning, save and except the South 150.04 feet of the West 150.04 feet thereof.

FROM R-2 to P-R (Z-37-68)

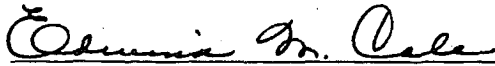

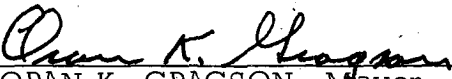

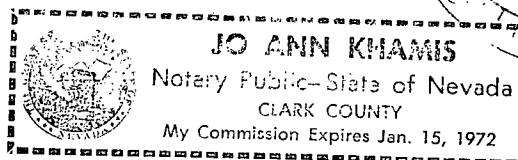

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

Commencing at the Southwest corner of said Section 22, thence North 01 degrees 24'55" East a distance of 50.0 feet to the true point of beginning; thence South 89 degrees 51'05" East a distance of 502.50 feet to a point; thence North 02 degrees 07'36" West a distance of 165.5 feet to a point; thence South 87 degrees 52'24" West a distance of 376.3 feet to a point; thence North 02 degrees 07'36" West a distance of 950.0 feet to a point; thence South 87 degrees 52'24" West a distance of 48.58 feet to a point; thence along a curve concave to the left, subtending a central angle of 93 degrees 32'31" with a radius of 10.0 feet, and an arc length of 16.33 feet to a point; thence South 01 degrees 24'55" West a distance of 1087.99 feet to the true point of beginning, save and except the South 150.04 feet of the West 150.04 feet thereof.
