

ORDINANCE NO. 934-155

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM P-R to C-1 (Z-4-69)

Lots 357, 358, and 359, Block 17, Hyde Park Subdivision #3.

FROM R-E to C-1 (Z-58-66)

The North 367.08 feet of the West 80 feet of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) and that portion of the North 367.08 feet of the Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) of Section 29, T.20S., R.61E., MDB&M, lying east of Rancho Road and South of Bonanza Road.

FROM R-1 to C-1 (Z-36-68)

Lots 25-28 (Inclusive), Block 3, Boulder Dam Homesite Tract #4

FROM R-1 to C-1 (Z-24-67)

The West 131.09 feet of the South 400 feet of the Southeast Quarter (SE 1/4) of Section 3, Township 21 South, Range 61 East, MDB&M.

FROM R-1 to C-1 (Z-1-66)

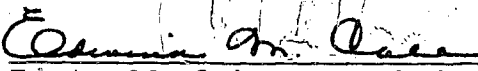
Lot 1, Block 1, Westwood Park Tract #1 and Lot 17, Pahor Tract.

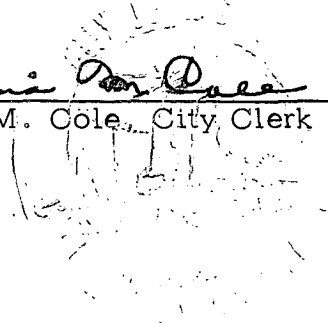
