

ORDINANCE NO. 934-160

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-4 to C-2 (Z-100-64)

Lots 9 and 10, Block 22, Clark's Las Vegas Townsite.

FROM R-E to C-1 (Z-1-66)

The East 140 feet of the North 144.86 feet of Lot 1, Ellis Estates.

FROM R-E to C-1 (Z-1-66)

The South 432.1 feet of the East 100 feet of the West 365.0 feet of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 33, Township 20 South, Range 61 East, M.D.B. & M.

FROM R-1 to P-R (Z-22-69)

Lot 474, Block 20, Hyde Park Subdivision No. 3.

FROM P-R to C-1 (Z-44-69)

Beginning at the Northeast Corner of Lot 24, Block 6, Richfield Village Unit No. 2-A; thence North 89°26'29" West a distance of 103.00 feet; thence South 0°33'31" West a distance of 51.00 feet; thence North 89°26'29" West a distance of 192.00 feet; thence North 0°33'31" East a distance of 150.00 feet to a point on the south right-of-way line of Sahara Avenue (150.00 feet wide); thence South 89°26'29" East along the said South right-of-way line a distance of 295.00 feet; thence South 0°33'31" West a distance of 99.00 feet to the point of beginning, excepting therefrom the West 192 feet.

Lot 1, Block 10 of Golfridge Terrace No. 2 and the South 10 feet
of Lot 2, Block 10, Golfridge Terrace Unit No. 5.

FROM R-E to C-1 (Z-1-66)

The South 432.1 feet of the East 100 feet of the West 365.0 feet of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 33, Township 20, South, Range 61 East M.D.B. & M.

FROM R-1 to P-R (Z-22-69)

Lot 474, Block 20, Hyde Park Subdivision No. 3.

FROM P-R to C-1 (Z-44-69)
