

ORDINANCE NO. 934-162

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

FROM R-1 to C-1 (Z-35-68)

The East 152.62 feet of the West 647.68 feet of the North 205.13 feet of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section 28, Township 20 South, Range 61 East, M.D.B.&M.

FROM R-2 to P-R (Z-36-69)

Lot 1, Block 1, Francisco Park #1.

FROM R-2 to C-1 (Z-37-69)

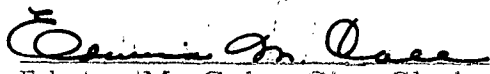
Lot 36, Block 2, Francisco Park #1.

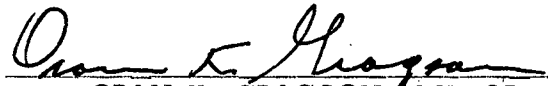

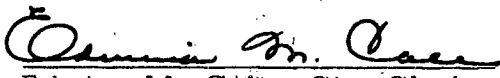
