

ORDINANCE NO. 934-166

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM C-V to R-1 (County Zoning Action Z-12-70)

A portion of the West Half (W 1/2) of Section 36, Township 20 South, Range 60 East, MDB&M, more particularly described as:

Commencing at the Northeast Corner of Lot 1, Block 1, Charleston Estates Tract #1, thence S.89°04'94"W., the distance of 180 feet to the true point of beginning; thence continuing S.89°09'04"W., a distance of 120 feet; thence S.0°53'24"W., a distance of 400 feet; thence N.89°09'04"E., a distance of 120 feet; thence N.0°53'24"W., a distance of 400 feet to the true point of beginning.

FROM R-1 to P-R (Z-85-69)

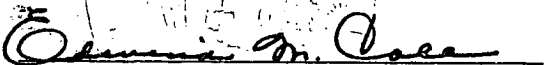
