

ORDINANCE NO. 934-176

AN ORDINANCE TO AMEND TITLE XI, CHAPTER I, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter I, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-2 to P-R (Z-33-70)

Lot 23, Block 6, Francisco Park #2.

FROM R-3 to C-1 (Z-65-69)

Lot 18, Block 1, Paradise Village Tract #1.

FROM R-4 to C-2 (Z-100-64)

Lots 21, 22, and 23, Block 7, South Addition.

FROM R-3 to C-1 (Z-45-69)

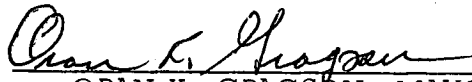
Lots 10 and 11, Block 6, Stewart Addition.

FROM R-4 to P-R (Z-17-70)

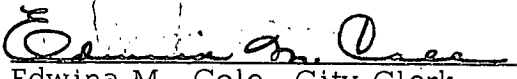
Lot 1, Block A, Beverly Green Tract No. 2.

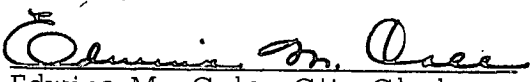

ORDINANCE No. 934-176

An ordinance to amend Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, by amending the land use plan map adopted by the City of Las Vegas, and changing the zoning designation of said map.
