

ORDINANCE NO. 934-181

AN ORDINANCE TO AMEND TITLE XI, CHAPTER I, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter I, Section 3 of the Municipal Code of the City of Las Vegas, Nevada 1960 Edition, is hereby amended to read as follows:

FROM R-2 and P-R to C-1 (Z-56-70)

Lots 17 and 18, Block 4, Francisco Park #1.

FROM R-3 to C-1 (Z-10-70)

Lots 12 and 13, Block 12, Las Verdes Heights #6, Unit #4.

FROM R-4 to C-2 (Z-100-64)

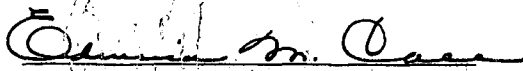
The East 60 feet of Lots 15 and 16, Block 12, South Addition.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

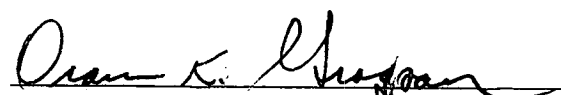

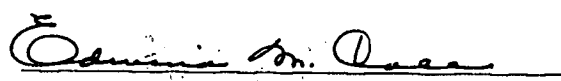
