WHEREAS, a committee composed of the following persons: Robert E. Jones, J. David Hoggard, Rulon A. Earl, Maxwell Kelch, William Peccole, A. C. Grant, and Howard W. Cannon, on April 23, 1951, submitted a study of the facts and circumstances surrounding the afore contemplated zone change to the Board of City Commissioners, and

That the following described property be rezoned from an R-E (Residence Estates) to R-1 (One-family residence) Zone, to-wit: That area of the NE $\frac{1}{4}$ of Section 28, T 20 S, R 61 E, MDB&M, commonly known as the Zaugg Tract, and being more particularly described as the E $\frac{1}{2}$ of the NE $\frac{1}{4}$, Section 28, T 20 S, R 61 E, MDB&M, and being that area east of J Street and West of H Street, bounded on the north by Harrison Street and on the South by Washington Street.

SECTION 2. That a minimum building area restriction of 1,850 square feet, exclusive of car ports, garages, and other residential building appurtenances, be imposed in that certain R-E Zone (Residence Estates) particularly described as follows, to-wit: The E $\frac{1}{2}$ of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 28, T 20 S, R 61 E, MDB&M, and commonly described as that part of the Zaugg Tract lying between J Street and K Street, and bounded on the north by Harrison Street and on the south by Washington Street.

SECTION 3. That a minimum building area restriction of 1,200 square feet exclusive of car ports, garages, and other residential building appurtenances, be imposed in that certain R-E Zone (Residence Estates) particularly described as follows, to-wit: The W $\frac{1}{2}$ of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 28, T 20 S, R 61 E, MDB&M, and commonly described as that part of the Zaugg Tract lying between K Street and Highland Avenue, and bounded on the north by Harrison Street and on the south by Washington.

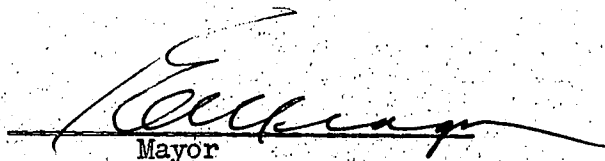
SECTION 4. That all ordinances or resolutions, or parts thereof, in conflict with the provisions of this ordinance, are hereby repealed. This repealer shall not be construed to revive any ordinance, nor resolution, or part thereof, heretofore repealed.

SECTION 5. That by reason of the fact that there is contemplated construction to be done immediately in the areas above described, and that such construction is needed to meet the present and future needs of the City and its inhabitants, and that it is necessary immediately to provide for such construction, therefore it is hereby declared that an emergency exists, and that this ordinance is necessary for the immediate preservation of the public peace, health and safety.

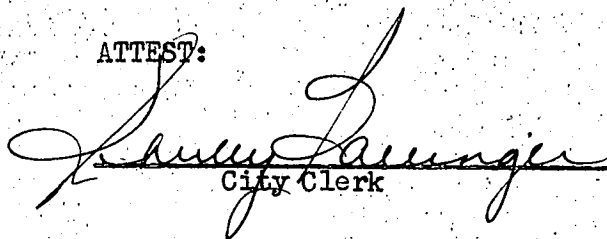
SECTION 6. This Ordinance is declared and passed as an emergency ordinance, and shall take effect immediately after its passage and publication.

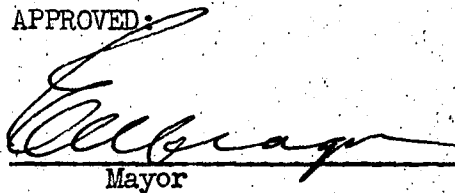

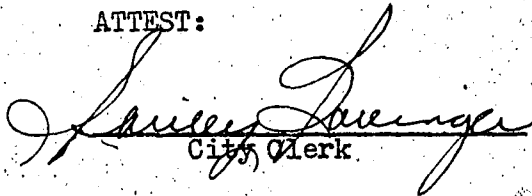

Jones, J. David Hoggard, Rulon A.
Earl, Maxwell Kelch, William Peccole,
A. C. Grant, and Howard W. Cannon,
on April 23, 1951, submitted a study
of the facts and circumstances sur-
rounding the afore contemplated zone
change to the Board of City Com-
missioners, and

WHEREAS, the Board of City Com-
missioners deem it to be in the pub-
lic interest that the aforesaid zone
changes be granted.

NOW, THEREFORE, THE BOARD
OF COMMISSIONERS OF THE CITY
OF LAS VEGAS DOES ORDAIN AS
FOLLOWS:

Section 1. That the following de-
scribed property be rezoned from an
R-E (Residence Estates) to R-1 (One
family residence) Zone, to-wit: That
area of the NE 1/4 of Section 28,
T. 20 S., R. 61 E., MDB&M, commonly
known as the Zaugg Tract, and being
more particularly described as the E 1/2
of the NE 1/4 Section 28, T. 20 S., R.
61 E., MDB&M, and being that area
east of J Street and West of H
Street, bounded on the north by Har-
rison Street and on the South by
Washington Street.

Section 2. That a minimum build-
ing area restriction of 850 square feet,
exclusive of car ports, garages, and
other residential building appurten-
ances, be imposed in that certain R-E
Zone (Residence Estates) particularly
described as follows, to-wit: The E 1/2
of the W 1/2 of the NE 1/4 of Section
28, T. 20 S., R. 61 E., MDB&M, and
commonly described as that part of
the Zaugg Tract lying between J
Street and K Street, and bounded on
the north by Harrison Street and on
the south by Washington Street.

Section 3. That a minimum build-
ing area restriction of 1,200 square
feet, exclusive of car ports, garages,
and other residential building appur-
tances, be imposed in that certain
R-E Zone (Residence Estates) particu-
larly described as follows, to-wit:
the W 1/2 of the W 1/2 of the NE 1/4
of Section 28, T. 20 S., R. 61 E.,
MDB&M, and commonly described
as that part of the Zaugg Tract
lying between K Street and Highland
Avenue, and bounded on the north by
Harrison Street and on the south by
Washington.

Section 4. That all ordinances or
resolutions, or parts thereof, in con-
flict with the provisions of this or-
dinance, are hereby repealed. This re-
pealer shall not be construed to revive
any ordinance, nor resolution, or part
thereof, heretofore repealed.

Section 5. That by reason of the
fact that there is contemplated con-
struction to be done immediately in
the areas above described, and that
such construction is needed to meet
the present and future needs of the
City and its inhabitants, and that
it is necessary immediately to pro-
vide for such construction, therefore
it is hereby declared that an emer-
gency exists, and that this ordinance
is necessary for the immediate pre-
servation of the public peace, health
and safety.

Section 6. This Ordinance is de-
clared and passed as an emergency
ordinance, and shall take effect im-
mediately after its passage and pub-
lication.

Section 7. The City Clerk and Clerk
of the Board of Commissioners of the
City of Las Vegas shall cause this
Emergency Ordinance No. 459 to be
published once a week for two succe-
ssive weeks immediately following its
final reading and adoption, in the
Las Vegas Review Journal, a daily
newspaper published in the City of
Las Vegas.
