

ORDINANCE NO. 934-204

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1. SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES
ORDAIN AS FOLLOWS:

Parcel 2. FROM R-2 to C-1.

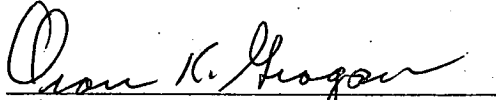
Lot 6, Block 5, Francisco Park #1.

FROM R-4 to C-2. (Z-100-64)

Lots 11 and 12, Block 23, Clark's Las Vegas
Townsite.

SECTION 2. All ordinances, parts or ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

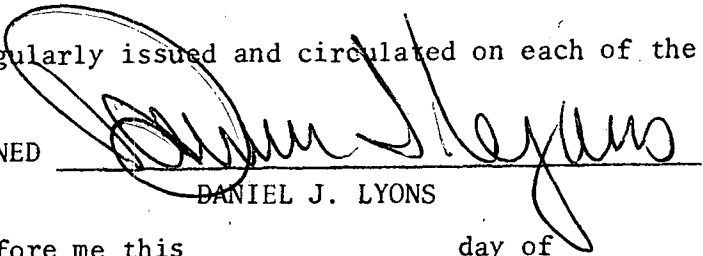
