

ORDINANCE NO. 934-206

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES
ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM C-1 to M (Z-66-64)

The East 50 feet of Lot 4, Block 3, East Park Industrial Subdivision.

FROM R-E to R-1 (Z-19-72)

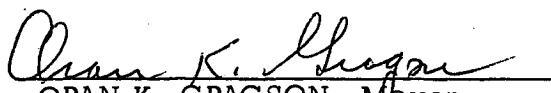
The Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 24, Township 20 South, Range 60 East, MDB&M., less the Easterly 330 feet and also less the West 330 feet of the South 400 feet.

FROM R-4 to P-R (Z-1-72)

Lots 14, 15, and 16, Block 31, South Addition.

SECTION 2. All ordinances, parts or ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

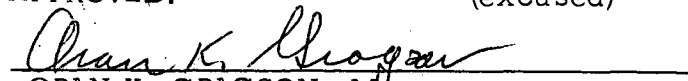

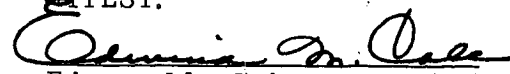
