

ORDINANCE NO. 934-207

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E to R-3 (Z-39-71)

That portion of the Northwest Quarter (NW1/4) of the Southwest Quarter (SW1/4) of Section 28, Township 20 South, Range 61 East, MDB&M., lying north of Bonanza Road, described as follows: Commencing at a point in the north line of the Southwest Quarter (SW1/4) of said Section 28 from which the west Quarter Corner bears North 89°12' West, a distance of 975 feet; thence South 0°25' East to a point in the north line of Bonanza Road (formerly Clark Avenue) as now established; thence South 89°36' East a distance of 358 feet to the True Point of Beginning; thence North 0°25' West a distance of 432.62 feet; thence North 89°36' West a distance of 167.00 feet; thence South 0°25' East a distance of 432.62 feet; thence South 89°36' East a distance of 167.00 feet to the True Point of Beginning.

FROM R-1 to P-R (Z-84-71)

Lot 14, Block 21, Huntridge Subdivision Tract #4

FROM R-3 to C-2 (Z-43-71)

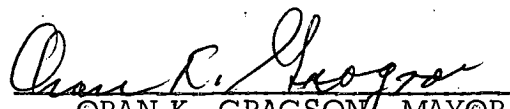

FROM R-4 to C-2 (Z-100-64)

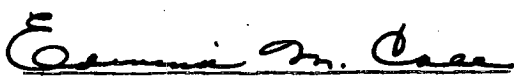
Lots 29 and 30, Block 15, South Addition.

The portion of the Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4) of Section 28, Township 20 South, Range 61 East, MDB&M, lying north of Bonanza Road, described as follows: Commencing at a point in the north line of the Southwest Quarter (SW 1/4) of said Section 28 from which the West Quarter Corner bears North 89 Degrees 12' West a distance of 975 feet; thence South 0 Degrees 25' East to a point in the north line of Bonanza Road (formerly Clark Avenue) as now established; thence South 89 Degrees 30' East a distance of 358 feet to the True Point of Beginning; thence North 0 Degrees 25' West a distance of 432.62 feet; thence North 89 Degrees 36' West a distance of 167.00 feet; thence South 0 Degrees 25' East a distance of 432.62 feet; thence South 89 Degrees 36' East a distance of 167.00 feet to the True Point of Beginning.
