

ORDINANCE NO. 934-212

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E to R-1 (Z-42-72)

The North Half (N 1/2) of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of Section 29, Township 20 South, Range 62 East, MDB&M.

FROM R-3 to R-1 to R-3 PUD (Z-29-70)

Lot 17, Block 12, Charleston Heights 44-C, and Lot 21, Block 1, Charleston Heights 39-A, and the following described parcel commencing at the Northwest corner of Section 25, Township 29 South, Range 60 East, MDB&M, the true point of beginning; thence S. 01°31'11" W., A distance of 1408.29 Feet to a point; Thence S. 89°57'54" E., A distance of 186.97 Feet to a point; thence N. 0°00'29" W., A distance of 877.63 Feet to a radius of 33.51 feet concave to the Southwest and having a delta angle of 48°14'44", A distance of 28.22 feet to a point on a radius of 33.51 feet concave to the Northeast and having a delta angle of 48°14'44", a distance of 28.22 feet to a point; thence N. 00°02'06" W., a distance of 216.00 feet to a point; thence S. 89°57'54" E., A distance of 890.05 feet to a point; thence N. 01°51'54" W., A distance of 223.05 feet to a point; thence S. 88°08'16" W., a distance of 1084.05 feet to the true point of beginning excepting therefrom the North 260 feet of the West 260 feet of said Section 25.

FROM R-1 to R-3 (Z-10-71)

Lots 7 and 8, Block 23, Wardle Addition

FROM R-1 to P-R (Z-5-66)

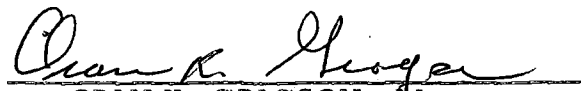
Lot 22, Block 1, Hyde Park Subdivision #1

FROM C-1 to C-M (Z-31-71)

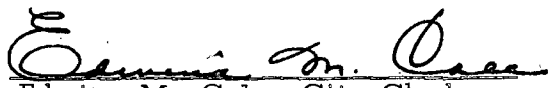

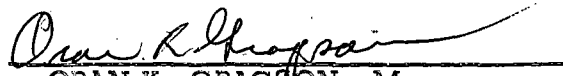

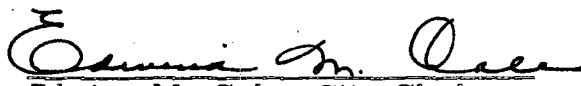

AN ORDINANCE TO AMEND
TITLE XI, CHAPTER 1, SECTION 3
OF THE MUNICIPAL CODE OF
THE CITY OF LAS VEGAS, NE-
VADA, 1960 EDITION; BY AMEND-
ING THE LAND USE PLAN MAP
ADOPTED BY THE CITY OF LAS
VEGAS, AND CHANGING THE
ZONING DESIGNATION OF SAID
MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E to R-1 (Z-42-72) the North Half (NW 1/4) of the North-west Quarter (NW 1/4) of the South-east Quarter (SE 1/4) of Section 29, Township 20 South, Range 62 East, MDB&M.

FROM R-3 to R-1 to R-3 PUD (Z-29-70).

Lot 17, Block 12, Charleston Heights 44E, and Lot 21, Block 1, Charleston Heights 39-A, and the following described parcel commencing at the Northwest corner of Section 25, Township 20 South, Range 60 East, MDB&M, the true point of beginning, thence S. 01°31'11" W. a distance of 1,408.29 feet to a point; thence S. 89°57'54" E. a distance of 186.97 feet to a point; thence N. 00°00'29" W. a distance of 877.63 feet to a radius of 33.51 feet concave to the Southwest and having a delta angle of 48°14'44". A distance of 28.22 feet to a point on a radius of 33.51 feet concave to the Northeast and having a delta angle of 48°14'44". a distance of 28.22 feet to a point; thence N. 00°00'00" W. a distance of 216.00 feet to a point; thence S. 89°57'54" E. a distance of 890.05 feet to a point; thence N. 00°00'00" W. a distance of 223.05 feet to a point; thence S. 88°08'16" W. a distance of 1084.05 feet to the true point of beginning excepting therefrom the North 260 feet of the West 260 feet of said Section 25.

Charleston Heights Townhouses No. 44D and 44E

FROM R-1 to R-3 (Z-10-71) — Lots 7 and 8, Block 23, Wordie Addition

FROM R-1 to R-3 (Z-5-66) — Lot 22, Block 1, Hyde Park Subdivision, No. 1

FROM C-1 to C-M (Z-31-71) — That portion of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of Section 28, Township 20 South, Range 61 East, MDB&M, described as follows: The North 380 feet of the East 265 feet of the West 305 feet of said Section 28.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses and phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed, and it is hereby adopted and PASSED, ADOPTED AND APPROVED this 19th day of July 1972.
