

ORDINANCE NO. 934-219

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM C-V to R-E (Z-83-72)

A portion of the west half (W 1/2) of the southeast quarter (SE 1/4) of the northwest quarter (NW 1/4) of Section 32, Township 20 south, Range 61 east, MDB&M, more particularly described as follows: Beginning at the northwest corner of Rancho Estates; thence S.0°04'23" east, 385.03 feet; thence N.89°22'20" west, 636.50 feet; thence N.0°08'00" west, 385.04 feet; thence S.89°22'20" east, 636.90 feet to the point of beginning.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, 1960 Edition, in conflict herewith are hereby repealed.
