

ORDINANCE NO. 934-228

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA,
DOES ORDAIN AS FOLLOWS:

SECTION 1: The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-1 and R-4 to C-1 (Z-5-63)

Parcel #1, - That portion of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section 33, Township 20 South, Range 61 East, described as follows: Beginning at the Northeast Corner of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section 33; thence Southerly along the East line thereof to the Southeast Corner of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section 33; thence westerly along the South line of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section 33 to the Southwest Corner thereof; thence Northerly along the West line of NE 1/4 of NW 1/4 of Section 33, a distance of 200' to a point; thence Easterly and parallel to the said South line a distance of 140' to a point; thence Northerly and parallel to the said West line to a point on the North line of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section 33; thence South 89°59'36" East along the said North line a distance of 1182.69' to the point of beginning.

FROM R-1 and R-4 to C-1 (Z-5-63)

Parcel #2 - That portion of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 28, Township 20 South, Range 61 East, described as follows: Beginning at the Southeast Corner of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of said Section 28; thence North 0°12'47" East along the East line thereof, a distance of 219.75' to a point; thence North 72°25'59" West a distance of 33.53' to a point; thence North 89°48'13" West a distance of 208.45' to a point; thence from a tangent whose bearing is the last described course turning to the right along a curve having a radius of 200' and subtending a central angle of 89°39'06" an arc length of 312.94' to a point; thence South 0°09'07" East a distance of 429.99' to a point on the South line of said Section 28; thence South 89°59'36" East a distance of 439' to the point of beginning.

FROM R-1 to R-6 (Z-5-63)

Parcel #3 - That portion of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 28, Township 20 South, Range 61 East, described as follows: Commencing at the Southeast Corner of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of said Section 28; thence North 89°59'36" West along the South line of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of said Section 28 a distance of 439' to the true point of

beginning; thence North 0°09'07" West a distance of 651.25' to a point; thence North 77°26'59" West a distance of 475.78' to a point; thence from a tangent whose bearing is North 82°21'53" West turning to the left along a curve having a radius of 3925' to a point on the West line of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of said Section 28; thence Southerly along the West line of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) to the Southwest Corner thereof; thence South 89°59'36" East along the said South line to the true point of beginning excepting therefrom Twin Lakes Village Unit #11.

Subject to the following conditions:

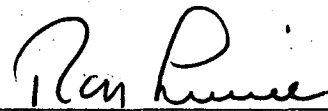
1. Conformance to plot plan, as amended, to provide for a six-foot high concrete block wall to the rear of the commercial development and the wall to be installed before they start development.
2. The South 100' of the West 200' of Parcel #1 being reserved for the parking only.
3. That no access to Shadow Lane from Parcel #1 be allowed.

SECTION 2: All ordinances or parts of ordinances, sections, subsections phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3: If any section, paragraph, sentence, phrase, term, word or connotation of this ordinance, or portion thereof, is for any reason held invalid, inapplicable or unconstitutional, by any court of competent jurisdiction; such holding shall not invalidate the remaining portions of this ordinance.

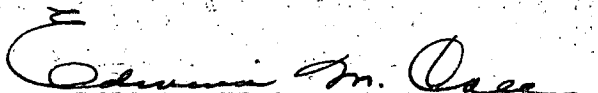

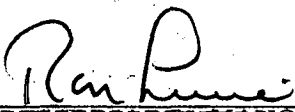
