

ORDINANCE NO. 934-108

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

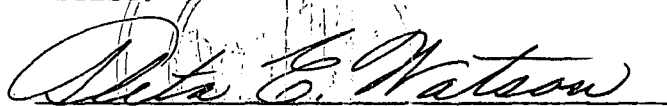
FROM C-2 AND R-4 TO C-M (Z-26-65)

Lots 1 to 4 (inclusive), Block 5, Original Las Vegas Townsite; the east 100.00 feet of Lots 21 through 24 (inclusive), Block 5, Original Las Vegas Townsite; that portion of the east-west alley adjacent to and north of Lots 1 through 4, Block 5, Original Las Vegas Townsite; and part of Lots 19 and 20 in said Block 5, being more particularly described as beginning at the northeast corner of Lot 21, in said Block 5, thence north $01^{\circ}40'18''$ west 50.00 feet, thence south $88^{\circ}19'07''$ west 34.15 feet; thence south $56^{\circ}25'40''$ west to a point 40.00 feet east of the west line of said Lot 20, thence south $01^{\circ}40'18''$ east to the south line of Lot 20, thence easterly along said south line a distance of 100.00 feet to the POINT OF BEGINNING.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 1. The Land Use Plan

as follows:

FROM C-1 AND R-4 TO C-1
(2-2-65)
Lots 1 to 4 inclusive, Block 5,
Original Las Vegas Townsite, the
east 4000 feet of Lot 21 through
24 inclusive, Block 5, Original
Las Vegas Townsite that portion
of the east-west alley adjacent to
and north of Lots 1 through 24,
Block 5, Original Las Vegas Town-
site, and part of Lots 19 and 20
in said Block 5 being more par-
ticularly described as beginning at
the northeast corner of Lot 24, the
said Block 5, thence north 0° 40' 10"
west 5000 feet, thence south 88°
10' 07" west 24.15 feet thence south
85° 25' 40" west to a point 4000 feet
east of the west line of said Lot
24, thence south 0° 40' 10" east to
the south line of Lot 20, thence
easterly along said south line a
distance of 100.00 feet, to the
POINT OF BEGINNING.

SECTION 2. All ordinances, parts

clauses or phrases contained in the
Municipal Code of the City of Las
Vegas, Nevada, 1960 Edition, in con-
