

ORDINANCE NO. 934-122

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E TO R-1 (Z-28-67)

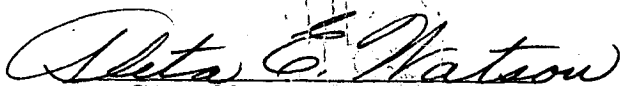
Commencing at the Northeast corner of Section 34, Township 20 South, Range 60 East, M.D.B. & M., thence North 89°36'04" West a distance of 710.80 feet to a point; thence South 0°57'19" East a distance of 60.02 feet to a point; thence North 89°36'04" West a distance of 381.11 feet to the True Point of Beginning; thence South 0°57'19" East a distance of 560.01 feet to a point; thence North 89°02'41" East a distance of 381.0 feet to a point; thence South 0°57'19" East a distance of 742.71 feet to a point; thence North 89°42'39" West a distance of 568.26 feet to a point; thence South 0°38'13" East a distance of 1,354.61 feet; thence North 89°49'35" West a distance of 1,301.79 feet; thence North 0°01'50" West a distance of 2,654.03 feet; thence South 89°36'04" East a distance of 1,453.77 feet to the True Point of Beginning.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

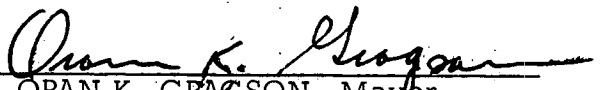

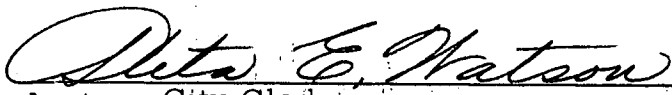

Commencing at the Northeast corner of Section 34, Township 20 South, Range 60 East, M.D.B. & M., thence North 89°36'04" West a distance of 710.80 feet to a point; thence South 0°57'19" East a distance of 260.02 feet to a point; thence North 89°36'04" West a distance of 381.11 feet to the True Point of Beginning; thence South 0°57'19" East a distance of 560.01 feet to a point; thence North 89°36'04" East a distance of 381.0 feet to a point; thence South 0°57'19" East a distance of 742.71 feet to a point; thence North 89°36'04" West a distance of 568.26 feet to a point; thence South 0°38'43" East a distance of 1,354.61 feet; thence North 89°49'35" West a distance of 1,301.79 feet; thence North 0°01'50" West a distance of 2,854.03 feet; thence South 89°36'04" East a distance of 1,453.77 feet to the True Point of Beginning.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub-sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.
