

ORDINANCE NO. 934-130

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E to C-1 (Z-42-66)

The North 199.65 feet of the West 235.10 feet of the Northwest Quarter (NW 1/4) of Section 36, Township 20 South, Range 61 East, M.D.B. & M.

FROM R-3 to R-1 (Z-31-67)

The South 380.0 feet of the West 958.0 feet of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 26, Township 20 South, Range 60 East, M.D.B. & M.

FROM R-4 to C-2 (Z-8-68)

Lot 15, Block 22, Boulder Addition.

FROM R-3 to R-4 (Z-9-68)

Lots 1 through 5, inclusive, Block 5, 14th Street City Addition.

FROM C-2 to R-E (Z-10-68)

Commencing at the Southeast corner of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of Section 35, Township 19 South, Range 60 East, M.D.B. & M.; thence North 0°23'44" West along the East line of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) a distance of 306.35 feet to the True Point of Beginning; thence continuing North 0°23'44" West a distance of 128.0 feet; thence North 83°20'36" West a distance of 216.37 feet; thence South 4°24'56" East a distance of 129.39 feet; thence South 83°40'36" East a distance of 207.24 feet to the True Point of Beginning.

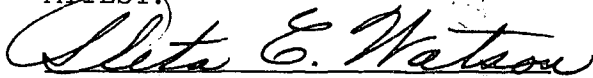
FROM P-R to C-1 (Z-11-68)

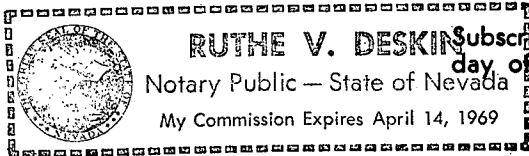
