Subject to the following conditions:

1. In the commercial area install minimum 15 foot wide landscaping planters along all street frontages to include 24 inch box mature evergreen trees 50 feet on center, raised berms, boulders, shrubs, and lawn ground cover and a 15 foot wide landscaping planter on the west property line with 24 inch box mature evergreen trees 40 feet on center and lawn ground cover as required by the Department of Community Planning and Development.

2. Construct a sidewalk on Highland Drive and half-street off-site improvements on Alta Drive as required by the Department of Public Works.
3. Provide a Drainage Plan and Technical Drainage Study to be submitted to and approved by the Department of Public Works prior to issuance of any building permits as required by the Department of Public Works.
4. Conformance to the plot plan and elevations.
5. Landscaping and a permanent underground sprinkler system shall be provided as required by the Planning Commission and shall be permanently maintained in a satisfactory manner. Failure to properly maintain required landscaping and underground sprinkler systems shall be cause for revocation of a business license.
6. Submittal of a landscaping plan prior to or at the same time application is made for a building permit, license or prior to occupancy, whichever occurs first.
7. All mechanical equipment, air conditioners and trash areas shall be screened from view from the abutting streets.
8. Satisfaction of City Code requirements and design standards of all City departments.
9. Approval of the parking and driveway plans by the Traffic Engineer.
10. Repair any damage to the existing street improvements resulting from this development as required by the Department of Public Works.
11. Provision of fire hydrants and water flow as required by the Department of Fire Services.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions,

1 paragraphs, sentences, clauses or phrases be declared unconstitu-
2 tional, invalid or ineffective.

3 SECTION 3: All ordinances or parts of ordinances, sec-
4 tions, subsections, phrases, sentences, clauses or paragraphs
5 contained in the Municipal Code of the City of Las Vegas, Nevada,
6 1983 Edition, in conflict herewith are hereby repealed.
