Summary: Amends the Zoning Map of the City of Las Vegas by changing the zoning designations of certain parcels of land

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: The Zoning Map adopted by Title 19, Chapter 2, Section 40, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

Z-55-66(13) From R-1 to P-R

Legally described as:

Lot 20 of Hyde Park Subdivision No. 1.

Z-31-83 From R-E to P-R

Legally described as:

Lot 14, Block 2 of Hinson Heights.

Z-32-85 From R-E and C-2 to C-2

Legally described as:

That portion of the East Half ($E\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section 34, Township 19 South, Range 60 East, M.D.B.&M., lying east of Oran K. Gragson Highway (U.S. 95) and Southwesterly of Rancho Drive, excepting the East 350' of the South 300'.

36 fact that any one or more sections, subsections, subdivisions,
37 paragraphs, sentences, clauses or phrases be declared unconstitu-
