

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-4 and C-2 to C-1: (Z-22-60)

South 450 feet of Southeast Quarter (SE $\frac{1}{4}$) of Southeast Quarter (SE $\frac{1}{4}$), Section 21, Township 20 South, Range 61 East.

From C-2 to R-4: (Z-23-60)

PARCEL 1.

The North 400 feet of the South 950 feet of SE $\frac{1}{4}$, SE $\frac{1}{4}$, Sec. 21, Township 20 South, Range 61 East, save and except that portion now zoned R-4.

From R-4 to R-3: (Z-23-60)

PARCEL 2.

The North 400 feet of SE $\frac{1}{4}$, SE $\frac{1}{4}$, Section 21, Township 20 South, Range 61 East, save and except that area now zoned R-3.

From R-4 to C-1: (Z-8-60)

Lot 2, Block 1, Charleston Square #3.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-4 and C-2 to C-1: (Z-22-60)
South 450 feet of Southeast Quarter (SE $\frac{1}{4}$) of Southeast Quarter (SE $\frac{1}{4}$), Section 21, Township 20 South, Range 61 East.

From C-2, R-3 to R-4: (Z-23-60)

PARCEL 1
The North 400 feet of the South 950 feet of SE $\frac{1}{4}$, SE $\frac{1}{4}$, Sec. 21, Township 20 South, Range 61 East, save and except that portion now zoned R-4.

From R-4 to R-3: (Z-23-60)

PARCEL 2
The North 400 feet of SE $\frac{1}{4}$, SE $\frac{1}{4}$, Sec. 21, Township 20 South, Range 61 East, save and except that area now zoned R-3.

From R-4 to C-1: (Z-23-60)
Lot 2, Block 1, Charleston Square No. 3.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.
