SECTION 4: Title 19, Chapter 4, Section 40, Subsection (C), of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by deleting the subdivision entitled "PAWN AUTO" and replacing it with a new subdivision entitled "PAWN, AUTO," reading as follows:

PAWN, AUTO [M]

1. The use shall comply with the applicable requirements of LVMC Chapter 6.60.
2. Except for the parking of automobiles, no outdoor display, sales or storage of any merchandise shall be permitted.
3. Vehicles that have been pawned may not be parked or stored in parking spaces that are designated as off-street parking necessary to meet the minimum requirements of LVMC Chapter 19.10. Any parking or storage of such vehicles must occur only in spaces that are in excess of the required minimum parking.
4. No auto pawn use shall be located on either side of Fremont Street or on Las Vegas Boulevard, between Charleston Boulevard and Sahara Avenue.

SECTION 5: Title 19, Chapter 4, Section 40, Subsection (C), of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto at the appropriate locations two new subdivisions, entitled "AUTO TITLE LOAN" and "FINANCIAL

3 designated as off-street parking necessary to meet the minimum requirements of LVMC Chapter
4 19.10. Any parking or storage of such vehicles must occur only in spaces that are in excess of the
5 required minimum parking.

6 4. No auto pawn use shall be located on either side of Fremont Street or on Las Vegas Boulevard,
7 between Charleston Boulevard and Sahara Avenue.

8 SECTION 7: Title 19, Chapter 20, Section 20, of the Municipal Code of the City of
9 Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto, at the appropriate locations,
10 the following terms and their corresponding definitions:

11 "Auto Title Loan" means a business whose primary function is to lend money on the security of the
12 title to a motor vehicle rather than on the security of the vehicle itself.

13 "Financial Institution, General" means any business or organization, including without limitation
14 banks and credit unions, whose primary service is the exchange of currency. The term does not
15 include any business engaged in retail sales or a business whose primary service is to lend money for
16 repayment at a future date.

17 "Financial Institution, Specified" means any business whose primary function is to lend money; to
18 cash checks or other negotiable instruments for a fee, service charge or other consideration; or to
19 provide funds in exchange for the acceptance of a check on a post-dated or deferred-deposit basis.
20 The term includes without limitation a check cashing service, paycheck advance service, and any
21 business primarily providing cash loans, installment loans or cash advances, but does not include a
22 pawn shop.

23 "Pawn, Auto" means a pawn shop that lends money on the security of a motor vehicle, which the
24 pawn shop takes possession of as the pledged property.

25 SECTION 8: In Sections 4, 5 and 6 of this Ordinance, the brackets that follow the
26 titles of the subdivision being added or amended are not intended to indicate deleted matter, but
27 instead are used as the means of indicating the applicable districts.

28 SECTION 9: For purposes of Section 2.100(3) of the City Charter, LVMC 19.04.010,

1 19.04.040, 19.04.050 and 19.20.020 are deemed to be subchapters rather than sections.

2 SECTION 10: The provisions of this Ordinance do not apply to any use that was
3 existing on November 6, 2002, or to any location which, as of that date, was licensed to operate or
4 concerning which an application for business license had been filed with the City. However, if any
5 existing use is discontinued for a period of one hundred eighty days, or if a license is not issued for,
6 or exercised at, a location specified above for a period of one hundred eighty days, the provisions of
7 this Ordinance shall apply to any future use of the property.

8 SECTION 11: If any section, subsection, subdivision, paragraph, sentence, clause or
9 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
10 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
11 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
12 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
13 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
14 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
15 invalid or ineffective.

16 SECTION 12: All ordinances or parts of ordinances or sections, subsections, phrases,
17 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
18 1983 Edition, in conflict herewith are hereby repealed.

AN ORDINANCE TO REVISE THE ZONING REQUIREMENTS FOR VARIOUS TYPES OF FINANCIAL INSTITUTIONS AND BUSINESSES, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Councilman Michael J. McDonald Summary: Revises the zoning requirements for various types of financial institutions and businesses.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Table 2 of the Land Use Tables adopted in Title 19, Chapter 4, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to reflect a change in the name of the use "Financial Institution" to "Financial Institution, General." In order to reflect the amendment, the rows that pertain to the uses "Financial Institution," as found in the "Office & Professional" Element of the Land Use Tables, shall read as follows:

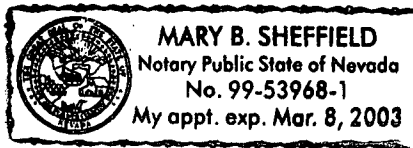

Sponsored by: Councilman Michael J. McDonald
Summary: Revises the zoning requirements for various types of financial institutions and businesses.

At the City Council meeting of DECEMBER 18, 2002
