ORDINANCE NO. 5564

AN ORDINANCE TO ALLOW THE USE "ASTROLOGER, HYPNOTIST, OR PSYCHIC ART AND SCIENCE" AS A PERMITTED USE IN THE C-1, C-2, C-M AND M ZONING DISTRICTS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Proposed by: Robert S. Genzer, Director of Planning and Development

Summary: Allows the use "Astrologer, Hypnotist, or Psychic Art and Science" as a permitted use in the C-1, C-2, C-M and M Zoning Districts.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Table 2 of the Land Use Tables adopted in Section 19.04.010 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by to allow the use "Astrologer, Hypnotist, or Psychic Art and Science" as a permitted use in the C-1, C-2, C-M and M Zoning Districts. In order to reflect the amendment, the "Retail & Personal Services" element of Table 2 is amended so that the row for that use appears as follows:

SECTION 2: Title 6, Chapter 12, Sections 30, 80 and 120, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby repealed in their entirety.

SECTION 3: For purposes of Section 2.100(3) of the City Charter, LVMC 19.04.010 is deemed to be a subchapter rather than a section.

SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,

1 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
2 invalid or ineffective.

3 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,
4 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
5 1983 Edition, in conflict herewith are hereby repealed.
