Summary: Authorizes the City Manager to waive
permit fee for wild animals being used principally for
educational purposes.

13 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
14 ORDAIN AS FOLLOWS:

15 SECTION 1: Title 7, Chapter 38, Section 10 of the Municipal Code of the
16 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

17 (A) No wild animal shall be exhibited in public or private or kept
18 anywhere within the city unless and until the owner thereof shall have obtained a wild animal
19 permit from the Animal Regulation Officer.

20 (B) Such wild animal permit shall not be issued for the keeping or
21 exhibiting of a wild animal until an investigation has been made to ascertain what precautions shall
22 be reasonable and necessary to protect the health, safety and general welfare of the public and of
23 the animal.

24 (C) Any person having as of the date of the adoption of the ordinance
25 codified in this chapter, or thereafter obtaining, owning, exhibiting, harboring, or having the care,
26 custody, or control of any wild animals, shall register such animals with the Animal Regulation
Officer and obtain a wild animal permit and shall pay for such permit and inspection the
nonrefundable sum of one hundred dollars for a time period as prescribed by the Animal
Regulation Officer for each animal; further, if such animals are warm-blooded animals, such

1 animals shall be subject to the rabies provisions of this Title as set forth in Chapter 7.12, subject
2 to the provisions of impoundment, and additionally subject, if impounded, to the requirement of
3 a wild animal permit before release to the owner thereof.

4 (D) The Animal Regulation Officer may issue a permit for each wild
5 animal or reptile that meets the below listed conditions. The application for permit shall have
6 attached thereto a veterinarian's certificate, certifying that said animal is properly vaccinated and
7 possesses no health hazard to itself, other animals, or the general public, for each animal to be
8 covered by the permit. Each permit application shall contain the following information

- 9 (1) Type of animal to be covered by the permit;
10 (2) Purpose of keeping such animals in question and experience
11 of such person in handling the animals in question:
12 (3) Period for which permit is requested;
13 (4) Description of the quarters in which the animal will be kept,
14 including plans and specifications, where appropriate;
15 (5) Circumstances, if any, under which the animal will be
16 removed from quarters;
17 (6) Name and address of applicant and any other person to be
18 placed in charge of the animal;
19 (7) And any other conditions as set forth by the Animal
20 Regulation Officer.

21 (E) After a review of all available information, including the permit
22 application, the criteria or standards of recognized societies or groups dealing with the animal in
23 question, and any citizen input, the Animal Regulation Officer may issue a permit for the keeping
24 of such animal if, in his considered judgment, such animal does not constitute a danger or
25 nuisance to the general public.

26 (F) The permit may be issued for a period as prescribed by the Animal

1 Regulation Officer upon payment of a one hundred dollar fee. Renewal permits need not be
2 subject to the application and notification procedures outlined in this Section unless the Animal
3 Regulation Officer deems that circumstances involving the animals have changed substantially
4 since the permit was last issued.

5 (G) The City Manager may waive the initial and renewal permit fees
6 required by this Section if the wild animals are principally used for educational purposes. In
7 making this determination, the City Manager will take into account such factors as the non-profit
8 or tax exempt status of the exhibitor or person possessing the wild animal and whether or not an
9 exhibit admission fee exists or a separate admission fee, in addition to a general admission fee,
10 is charged to see a wild animal exhibit.

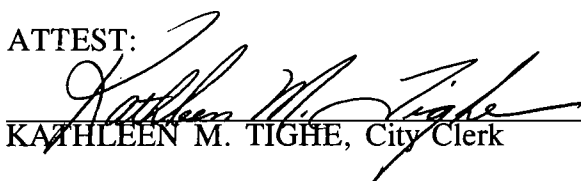
11 SECTION 2: If any section, subsection, subdivision, paragraph,
12 sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be
13 unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision
14 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part
15 thereof. The City Council of the City of Las Vegas hereby declares that it would have passed
16 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective
17 of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses
18 or phrases be declared unconstitutional, invalid or ineffective.

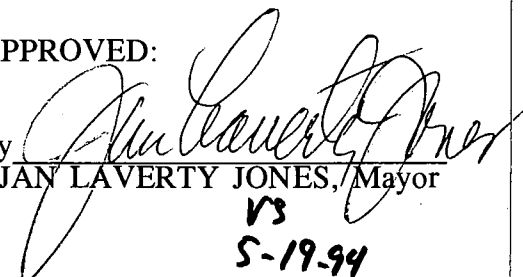

Summary: Authorizes the City Manager to waive permit fee for wild animals being used for educational purposes.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 38, Section 10 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

(A) No wild animal shall be exhibited in public or private or kept anywhere within the city unless and until the owner thereof shall have obtained a wild animal permit from the Animal Regulation Officer.

(B) Such wild animal permit shall not be issued for the keeping or exhibiting of a wild animal until an investigation has been made to ascertain what precautions shall be reasonable and necessary to protect the health, safety and general welfare of the public and of the animal.

(C) Any person having as of the date of the adoption of the ordinance codified in this chapter, or thereafter obtaining, owning, exhibiting, harboring, or having the care, custody, or control of any wild animals, shall register such animals with the Animal Regulation Officer and obtain a wild animal permit and shall pay for such permit and inspection the nonrefundable sum of one hundred dollars for a time period as prescribed by the Animal Regulation Officer for each animal; further, if such animals are warm-blooded animals, such animals shall be subject to the rabies provisions of this Title as set forth in Chapter 7.12, subject to the provisions of impoundment, and additionally subject, if impounded, to the requirement of

1 a wild animal permit before release to the owner thereof.

2 (D) The Animal Regulation Officer may issue a permit for each wild

9 thereof. The City Council of the City of Las Vegas hereby declares that it would have passed
10 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective
11 of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses
12 or phrases be declared unconstitutional, invalid or ineffective.

13 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
14 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
15 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

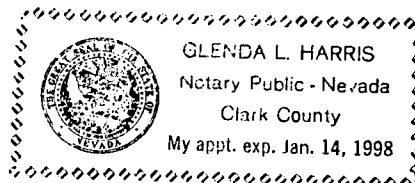

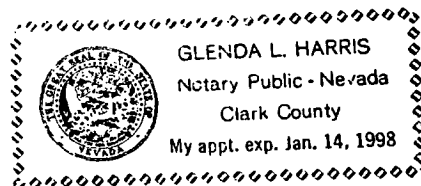
