30 remaining portions of this Chapter or any part thereof. The Board

32 declares that it would have passed each section, subsection,

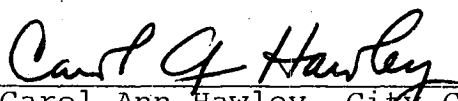
1 subdivision, paragraph, sentence, clause or phrase thereof,

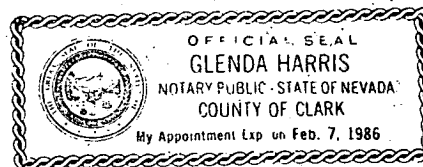

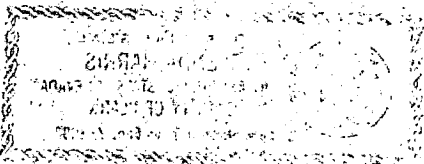
