SECTION 1: The Master Plan of Streets and Highways provided for in Title 13, Chapter 12, Section 30 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by: Craig Road is reduced in width from 150 feet to 120 feet between Rancho Drive and Jones Boulevard.

SECTION 2: The Master Plan of Streets and Highways provided for in Title 13, Chapter 12, Section 30 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by: Special Design No. 115-368, on file in the Division of Engineering Design, is hereby adopted.

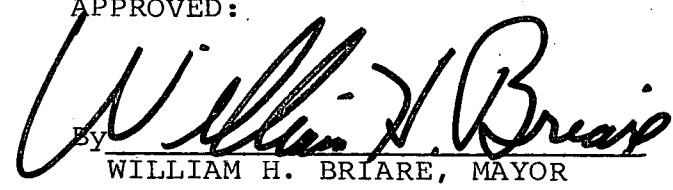

3 declared unconstitutional, invalid or ineffective.

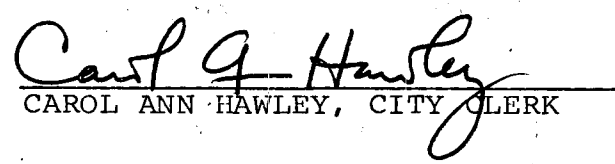

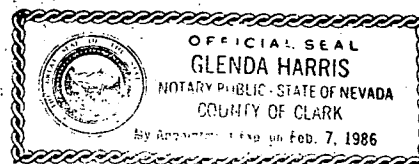
