AN ORDINANCE RELATING TO BUSINESS LICENSING; AMENDING TITLE 6, CHAPTER 2, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 65, TO PROVIDE FOR AN EXEMPTION FROM THE BUSINESS LICENSING REGULATIONS OF SAID CITY FOR THE EMPLOYEES OF BUSINESSES WHICH ARE DULY LICENSED PURSUANT TO SUCH REGULATIONS AND FOR COMMUNITY THEATRES; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREOF.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 2, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 65, to read as follows:

6.02.065: Nothing in this Title, including the imposition of any license tax, shall be deemed or construed to apply to any:

(A) Person engaged in any of the professions or occupations hereinafter enumerated solely as an employee of any other person conducting, managing, or carrying on any such business unless specifically provided otherwise by this Title.

(B) Community theatre as defined in NRS 364.130.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the

1 remaining portions of this Chapter or any part thereof. The Board
2 of City Commissioners of the City of Las Vegas, Nevada, hereby
3 declares that it would have passed each section, subsection, sub-
4 division, paragraph, sentence, clause or phrase thereof, irrespec-
5 tive of the fact that any one or more sections, subsections,
6 subdivisions, paragraphs, sentences, clauses or phrases be declared
7 unconstitutional, invalid or ineffective.

SECTION 3: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

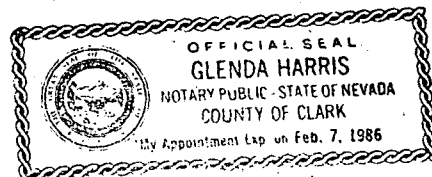

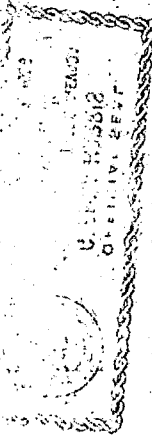
