4 AN ORDINANCE TO AMEND TITLE 11, CHAPTER 48 OF THE MUNICIPAL CODE
5 OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO
6 A NEW SECTION, TO BE DESIGNATED AS SECTION 100, PERTAINING TO
7 OPERATION OF OVER-LENGTH VEHICLES ON ROUTES OR STREETS WITHIN SAID
8 CITY, SETTING FORTH BY WAY OF AN APPROVED SCHEDULE THOSE ROUTES
9 UPON WHICH SUCH VEHICLES MAY BE OPERATED AND REQUIRING THE OBTAIN-
10 ING OF A PERMIT TO OPERATE SUCH OVER-LENGTH VEHICLES ON ROUTES OR
11 STREETS WITHIN SAID CITY AND NOT LISTED ON THE APPROVED SCHEDULE;
12 PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND
13 REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT
14 HEREWITH.

13 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
14 NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

15 SECTION 1: Title 11, Chapter 48 of the Municipal Code
16 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended
17 to add a new section, to be designated as Section 100, reading as
18 follows:

19 11.48.100 No person shall operate any vehicle, or any
20 combination of vehicles coupled together, which exceed seventy
21 feet (70') in length upon any street, highway or alley within the
22 City except as follows:

23 (A) Such over-length vehicles are allowed on those routes
24 described in Schedule 29-1, and as may be amended from time to
25 time by resolution of the Board of City Commissioners. Said
26 Schedule 29-1 shall be kept in the office of the City Clerk for
27 public inspection, and copies thereof may be obtained from the
28 City Clerk or from the Traffic Engineer for the City.

29 (B) Such over-length vehicles are allowed on those routes or
30 streets, other than those described in Schedule 29-1, for
31 which the Department of Public Services has issued a permit.

32 Upon receipt of a written application and the payment of a fifty

1 dollar (\$50.00) application fee, the Department of Public Services
2 may issue a temporary permit authorizing the operation of such
3 over-length vehicle on the routes or streets stated therein pro-
4 vided that the Department of Public Services determines that such
5 operation will not unduly threaten the safety and convenience of
6 persons or property. Such permit may contain limitations as to
7 the origin, destination, time or specific routes of travel and
8 such other limitations as the Director of Public Services considers
9 necessary to protect the interest of the public. If an application
10 is denied, the applicant may appeal the denial to the Board of
11 Commissioners by filing a written notice of appeal with the City
12 Clerk within fifteen (15) days following notice of denial. The
13 notice of denial becomes effective upon its deposit in the U.S.
14 mails addressed to the applicant at the address as shown on the
15 application.

16 SECTION 2: If any section, subsection, subdivision,
17 paragraph, sentence, clause or phrase in this Chapter or any
18 part thereof, is for any reason held to be unconstitutional, or
19 invalid or ineffective by any court of competent jurisdiction,
20 such decision shall not affect the validity or effectiveness of
21 the remaining portions of this Chapter or any part thereof. The
22 Board of Commissioners of the City of Las Vegas hereby declares
23 that it would have passed each section, subsection, subdivision,
24 paragraph, sentence, clause or phrase thereof irrespective of
25 the fact that any one or more sections, subsections, subdivisions,
26 paragraphs, sentences, clauses or phrases be declared unconstitu-
27 tional, invalid or ineffective.

28 SECTION 3: All ordinances or parts of ordinances,
29 sections, subsections, phrases, sentences, clauses or paragraphs

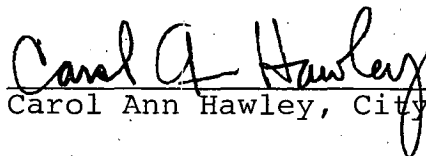

SCHEDULE 29-1

AUTHORIZED ROUTES OF VEHICLES IN EXCESS OF SEVENTY FEET: In accordance with the provisions of Title 11, Chapter 48, Section 100 of the Las Vegas Municipal Code, 1983 Edition, vehicles in excess of seventy feet (70') are permitted to travel on the following authorized streets, highways or alleys within the City:

1. Bonanza Road - from Rancho Drive to Main Street
2. Main Street - from the north City limits to Las Vegas Boulevard South
3. Rancho Drive - from the north City limits of Las Vegas to Bonanza Road
4. Sahara Avenue - from Interstate #15 to Fremont Street
5. Las Vegas Boulevard - from St. Louis Avenue to Sahara Avenue

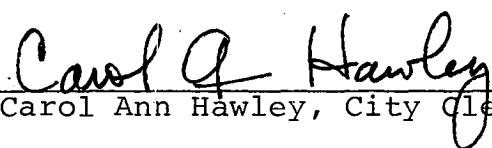

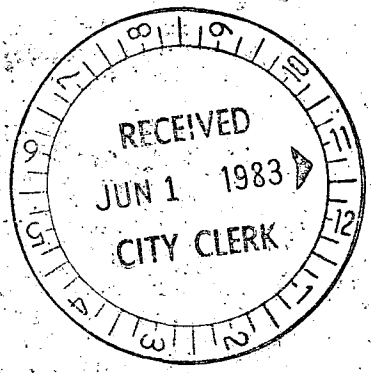
