THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 11, Chapter 56, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, to be designated as Section 40, reading as follows:

11.56.040 Any person who is licensed to film or photograph for movies, promotions or advertising must obtain a permit from the City Manager before it may use any street, alley or City property in such filming or photographing.

SECTION 2: Title 11, Chapter 56, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.56.010 No funeral, procession, running or bicycle marathon or similar event or parade [containing two hundred or more persons or fifty or more vehicles], excepting the forces of the United States Army, Air Force, Marines and Navy, the military forces of this State, and the forces of the Metropolitan Police and Fire Services

1 Departments, [shall] may occupy, march or proceed along
2 any street or right of way except in accordance with a
3 permit issued by the [Sheriff] Las Vegas Metropolitan
4 Police Department and approved by the City Manager and
5 such other regulations as are set forth herein which
6 may apply.

7 SECTION 3: Title 11, Chapter 56, Section 20, of the
8 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
9 hereby amended to read as follows:

10 11.56.020 No driver of a vehicle [shall] may drive between the
11 vehicles [composing] or persons which comprise a funeral
12 or other authorized procession or a parade while [they
13 are] it is in motion and when such vehicles or persons
14 are conspicuously designated as required in this Chapter.
15 This provision shall not apply at intersections where
16 traffic is controlled by traffic[-control] signals or
17 Police Officers, nor shall it apply to the drivers of
18 authorized emergency vehicles when such drivers are
19 [engaged in official business] responding to an
20 emergency.

21 SECTION 4: If any section, subsection, subdivision,
22 paragraph, sentence, clause or phrase in this Chapter or any part
23 thereof, is for any reason held to be unconstitutional or invalid
24 or ineffective by any court of competent jurisdiction, such
25 decision shall not affect the validity or effectiveness of the
26 remaining portions of this Chapter or any part thereof. The
27 Board of City Commissioners of the City of Las Vegas, Nevada,
28 hereby declares that it would have passed each section, subsec-
29 tion, subdivision, paragraph, sentence, clause or phrase thereof,
30 irrespective of the fact that any one or more sections, subsec-
31 tions, subdivisions, paragraphs, sentences, clauses or phrases be
32 declared unconstitutional, invalid or ineffective.

1 SECTION 5: Whenever in this ordinance any act is pro-
2 hibited or is made or declared to be unlawful or an offense or
3 a misdemeanor, or whenever in this ordinance the doing of any act
4 is required or the failure to do any act is made or declared to
5 be unlawful or an offense or a misdemeanor, the doing of any such
6 prohibited act or the failure to do any such required act shall
7 constitute a misdemeanor and upon conviction thereof, shall be
8 punished by a fine of not more than \$1,000.00 or by imprisonment
9 for a term of not more than six months, or by any combination of
10 such fine and imprisonment. Any day of any violation of this
11 ordinance shall constitute a separate offense.

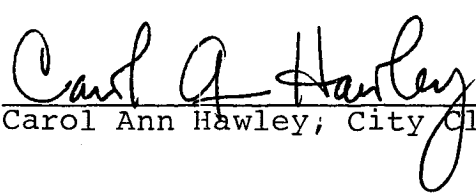

AN ORDINANCE RELATING TO TAXATION; AMENDING TITLE 4, CHAPTER 20, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION 35, TO IMPOSE A SUPPLEMENTAL 1% TAX ON REVENUES FROM THE RENTAL OF TRANSIENT LODGING WITHIN SAID CITY; AMENDING SECTION 10 OF SAID TITLE AND CHAPTER TO DESIGNATE THE PURPOSE OF IMPOSING SAID SUPPLEMENTAL 1% TAX; AMENDING SECTION 160 OF SAID TITLE AND CHAPTER TO PROVIDE FOR THE DISPOSITION OF THE AMOUNTS RECEIVED BY SAID CITY AS A RESULT OF THE IMPOSITION OF SAID SUPPLEMENTAL 1% TAX; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 4, chapter 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, to be designated as Section 35, reading as follows:

4.20.035: There is fixed and imposed a supplemental tax on all room revenues derived by each hotel, motel or other establishment which offers rooms to the public on a daily basis or for periods of less than one week which are located in the City in the amount of 1% of all monies received from room rentals by that establishment.

SECTION 2: Title 4, chapter 20, section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

4.20.010: (A) The taxes imposed by [this Chapter] Sections 4.20.030 and 4.20.080 are for the purpose of constructing and supporting convention halls and related facilities by the Las Vegas Convention and Visitors Authority for the benefit of the City

1 and its residents and for the fulfillment of
2 statutory requirements of NRS 244A.645 and any
3 agreements of the City with the Las Vegas Conven-
4 tion and Visitors Authority and other government
5 entities in Clark County, Nevada, in pursuance
6 thereof concerning the pledge or commitment of
7 these taxes.

8 (B) The taxes imposed by Section 4.20.035 are for
9 the purpose of supporting the Nevada Department
10 of Economic Development and advertising the
11 resources of the City which are related to tourism,
12 including available accommodations, transportation,
13 entertainment, natural resources and climate, and
14 to promote special events which are related thereto.

15 SECTION 3: Title 4, chapter 20, section 160, of the
16 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
17 hereby amended to read as follows:

18 4.20.160: The Director of the [Finance] Department of Financial
19 Management of the City shall, within twenty days from
20 the close of the preceding calendar month, transmit
21 [the]:

22 (A) The total amount received pursuant to Sections
23 4.20.030 and 4.20.080 to the Las Vegas Convention
24 and Visitors Authority to be used for the purposes
25 set forth in [this Chapter.] subsection (A) of
26 Section 4.20.010.

27 (B) Three-eighths of the total amount received pursuant
28 to Section 4.20.035 to the Nevada Department of
29 Taxation for deposit with the State Treasurer for
30 credit to the fund for the promotion of tourism.

31 (C) Five-eighths of the total amount received pursuant
32 to Section 4.20.035 to the Las Vegas Convention

1 and Visitors Authority to be used for the purposes
2 set forth in subsection (B) of Sections 4.20.010.

3 SECTION 4: If any section, subsection, subdivision,
4 paragraph, sentence, clause or phrase in this Chapter or any part
5 thereof, is for any reason held to be unconstitutional or invalid
6 or ineffective by any court of competent jurisdiction, such
7 decision shall not affect the validity or effectiveness of the
8 remaining portions of this Chapter or any part thereof. The

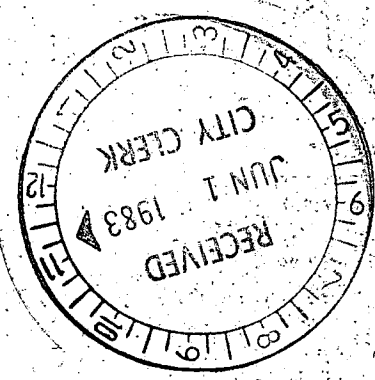

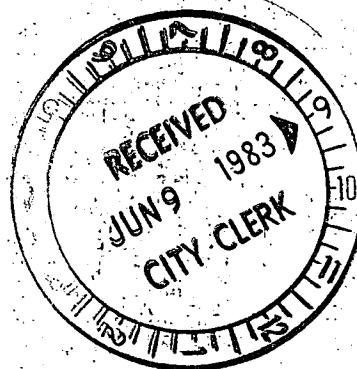
