THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA,
DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby extended to include, annex to, and make a part of the City of Las Vegas, Nevada, the following described real property, to-wit:

Government Lots 11 and 14 in Section 2, Township 21 South, Range 60 East, M.D.M., in the County of Clark, State of Nevada, described as follows:

BEGINNING at the Northeast corner of Government Lot 11 in said Section 2; thence along the East line of said Government Lots 11 and 14, South 02°47'02" East a distance of 1366.57 feet to the South line of said Government Lot 14; thence along said South line of Government Lot 14; South 88°53'56" West a distance of 329.59 feet to the West line of said Government Lot 14; thence along the West line of said Government Lots 14 and 11, North 02°43'38" West a distance of 1370.54 feet to the North line of said Government Lot 11; thence along said North line of Government Lot 11, North 89°39'59" East a distance of 204.05 feet; thence continuing along said North line of Government Lot 11, North 89°29'09" East a distance of 124.39 feet to the POINT OF BEGINNING.

SECTION 2: That said City Council has determined and does hereby determine, that said described territory meets the

15 the City, said petition constituting one hundred
16 percent (100%) of the owners of record of individual
17 lots or parcels of land within the annexation area,
18 and have submitted a letter of intent to develop
19 the land.

20 SECTION 3: The City of Las Vegas will provide police
21 protection through the Las Vegas Metropolitan Police Department,
22 fire protection, street maintenance, and library services
23 immediately upon annexation. Garbage collection by the company
24 franchised by the City will also be provided immediately. The
25 City sanitary sewer system will serve the proposed annexation
26 area. Any connection to or extension of this sewer line to serve
27 the annexation area shall be at the expense of the landowners.
28 Other services, such as participation in the City's recreational
29 programs, special educational classes and programs, public works
30 planning, building inspections, and other City Hall services
31 will also be available immediately. Utilities such as gas,
32 electricity, telephone, and water are provided by private utility

1 companies and other services to the area will not be affected by
2 annexation. Street paving, curbs and gutters, sidewalks and
3 street lights which are not in place at the time of annexation
4 will be installed in the presently developed areas upon the
5 request of the property owners and at their expense by means
6 of special assessment districts. Such improvements will be
7 extended into the undeveloped areas as development takes place
8 and the need therefor arise, and will be located according to
9 the needs of the area at that time. Such installations will
10 also be made at the expense of the property owners, either by
11 means of special assessment districts or as prerequisites to the
12 approval of subdivision plats or the issuance of building permits,
13 re-zonings, zone variances or special use permits.

14 SECTION 4: The annexation of said described territory
15 shall become effective on the 12th day of August, 1983, and on such
16 date the City of Las Vegas will have the funds appropriated in
17 sufficient amount to finance the extension into said described
18 territory of police protection, fire protection, street
19 maintenance, street sweeping, and street lighting maintenance.

20 SECTION 5: Said described territory, together with the
21 inhabitants and property thereof, shall, from and after the 12th
22 day of August, 1983, be subject to all debts, laws, ordinances and
23 regulations in force in the City of Las Vegas and shall be entitled
24 to the same privileges and benefits as other parts of said City,
25 and shall be subject to municipal taxes levied by the City of
26 Las Vegas, Nevada.

27 SECTION 6: The City Engineer of the City of Las Vegas,
28 Nevada, is hereby instructed to cause to be prepared an accurate
29 map or plat of said described territory and to record the same,
30 together with a certified copy of this ordinance in the office of
31 the County Recorder of Clark County, Nevada, which said recording
32 shall be done prior to the 12th day of August, 1983.

1 SECTION 7: If any section, subsection, subdivision,
2 paragraph, sentence, clause or phrase in this Chapter or any
3 part thereof, is for any reason held to be unconstitutional, or
4 invalid or ineffective by any court of competent jurisdiction,
5 such decision shall not affect the validity or effectiveness of
6 the remaining portions of this Chapter or any part thereof. The
7 City Council of the City of Las Vegas hereby declares that it
8 would have passed each section, subsection, subdivision, para-
9 graph, sentence, clause or phrase thereof irrespective of the
10 fact that any one or more sections, subsections, subdivisions,
11 paragraphs, sentences, clauses or phrases be declared unconstitu-
12 tional, invalid or ineffective.

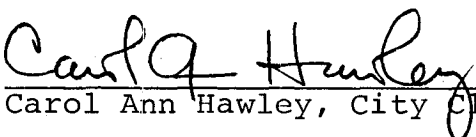
13 SECTION 8: All ordinances or parts of ordinances,

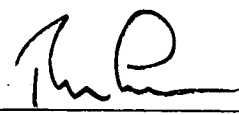

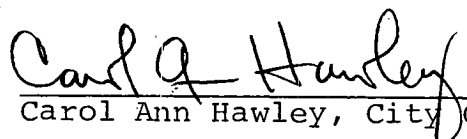
