AN ORDINANCE RELATING TO THE DEFINITION OF WORDS AND PHRASES IN THE LAS VEGAS MUNICIPAL CODE; AMENDING TITLE 1, CHAPTER 4, SECTION 20, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO PROVIDE DEFINITIONS FOR THE PHRASE "CITY COUNCIL" AND THE WORD "COUNCIL"; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, DOES
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 1, Chapter 4, Section 20, of the
Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
is hereby amended to read as follows:

1.04.020: In the construction of this Code, and of all ordinances,
the following definitions and rules shall be observed,
unless such construction would be inconsistent with the
manifest intent of the [Board of Commissioners:]

City Council:

- (A) ["The Board" means the Board of Commissioners of
the City of Las Vegas.
- (B)] "The City" or "this City" shall be construed as if
the words "of Las Vegas, Clark County, Nevada"
followed.
- (B) "The City Council", the "Council", "the Board of
Commissioners" and "the Board" each means the
governing body of the City of Las Vegas.
- (C) Computation of time: The time within which an act
is to be done shall be computed by excluding the
first and including the last day, and if the last
day be Sunday or a legal holiday, that shall be

excluded.

(D) "The County" or "this County" shall mean the County of Clark.

(E) Gender: The masculine gender shall include the feminine and neuter genders. The use of a masculine noun or pronoun in conferring a benefit or imposing a duty does not exclude a female person from that benefit or duty. The use of a feminine noun or pronoun in conferring a benefit or imposing a duty does not exclude a male person from that benefit or duty.

(F) Joint authority: All words which give authority jointly to three or more persons or officers shall be construed as giving such authority to a majority of such persons or officers.

(G) "Keeper" and "Proprietor" mean and include persons, firms, associations, corporations, clubs, and copartnerships, whether acting by themselves or through servants, agents, or employees.

(H) "Month" means a calendar month, unless otherwise specified.

(I) Number: The singular number includes the plural number and the plural number includes the singular number.

(J) "Oath" includes an affirmation in all cases in which, by law, an affirmation may be substituted for an oath, and in such cases the words "swear" and "sworn" shall be equivalent to the words "affirm" and "affirmed."

(K) "Or" may be read "and," and "and" may be read "or;" if the sense requires it.

(L) "Owner;" applied to a building or land, includes

1 any part owner, joint owner, tenant in common,
2 tenant in partnership, joint tenant, or tenant by
3 the entirety, of the whole or a part of such
4 building or land.

5 (M) "Person" includes a corporation, firm, partnership,
6 association, organization, and any other group
7 acting as a unit, as well as an individual.

8 (N) "Personal property" includes every type or species
9 of property, except real property, as hereinafter
10 defined.

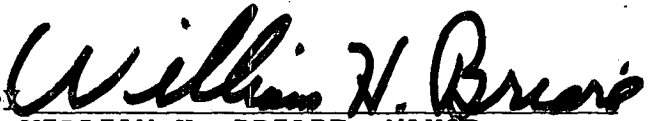
11 SECTION 2: If any section, subsection, subdivision,
12 paragraph, sentence, clause or phrase in this Chapter or any part
13 thereof, is for any reason held to be unconstitutional or invalid
14 or ineffective by any court of competent jurisdiction, such
15 decision shall not affect the validity or effectiveness of the
16 remaining portions of this Chapter or any part thereof. The
17 City Council of the City of Las Vegas, Nevada, hereby declares
18 that it would have passed each section, subsection, subdivision,
19 paragraph, sentence, clause or phrase thereof, irrespective of
20 the fact that any one or more sections, subsections, subdivisions,
21 paragraphs, sentences, clauses or phrases be declared unconstitu-
22 tional, invalid or ineffective.

23 SECTION 3: All ordinances or parts of ordinances,
24 sections, subsections, phrases, sentences, clauses or paragraphs

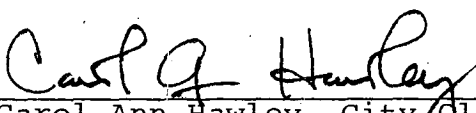
