

ORDINANCE NO. 934-63

AN ORDINANCE TO AMEND ORDINANCE NO. 934-60; TO AMEND TITLE XI, CHAPTER 1, SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Ordinance No. 934-60 is hereby amended to read as follows:

FROM R-E to R-1 (Z-52-64)

The East Half of the West Half of the Southeast Quarter of Section 34, Township 20 South, Range 60 East, M.D.B.&M.

FROM R-4 to C-2 (Z-54-64)

Lots 27 through 32, inclusive, Block 28, Clark's Las Vegas Townsite.

FROM R-E to R-1 (Z-56-64)

All of the Northeast Quarter of Section 19, Township 20 South, Range 61 East, M.D.B.&M., lying East of the centerline of U. S. Highway No. 95, save and except the Westerly 660 feet paralleling the centerline of said U. S. Highway No. 95.

SECTION 2. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

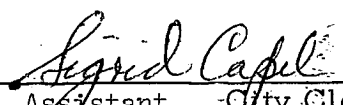
FROM R-2 to P-R (Z-50-64)

Lots 3 and 4, Block 3, Paradise Village Tract #4.

SECTION 3. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

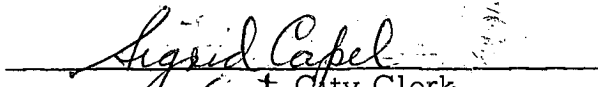

AN ORDINANCE TO AMEND ORDINANCE NO. 934-60; TO AMEND TITLE XI, CHAPTER 1, SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:
SECTION 1: Ordinance No. 934-60 is hereby amended to read as follows:

FROM R-E to R-1 (Z-52-64)
The East Half of the West Half of the Southeast Quarter of Section 34, Township 20 South, Range 60 East, M.D.B. & M.
FROM R-4 to C-2 (Z-54-64)
Lots 27 through 32, inclusive, Block 28, Clark's Las Vegas Township.

FROM R-E to R-1 (Z-56-64)
FROM R-E to R-1 (Z-56-64)
All of the Northeast Quarter of Section 17, Township 20 South, Range 61 East, M.D.B. & M., lying East of the centerline of U.S. Highway No. 95, save and except the Westerly 660 feet paralleling the centerline of said U.S. Highway No. 95.

SECTION 2: The Land Use Plan Map adopted by Title VI, Chapter 1, Section 3 of the Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

FROM R-2 to R-1 (Z-50-64)
Lots 1 and 4, Block 3, Paradise Village Tract.

SECTION 3: All ordinances, parts of ordinances, chapters, sections, sub-sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.
