

ORDINANCE NO. 934-54

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

FROM C-C to C-M (Z-24-63)

The east 373.00 feet of the south 303.00 feet of the Southeast Quarter (SE 1/4) of Section 3, Township 21 South, Range 61 East, M. D. B. & M.

FROM R-E to R-1 (Z-65-63)

Parcel 1:

A portion of the Southwest Quarter (SW 1/4) of Section 30, Township 20 South, Range 62 East, M.D.B. & M., and being more particularly described as beginning at the East Quarter corner of the Southwest Quarter (SW 1/4) of said Section 30; thence South 1130.00 feet; thence West 1280.00 feet; thence North 450.00 feet; thence North 45° West 960.00 feet; thence East 1960 feet to the point of beginning.

Parcel 2:

The West 990.00 feet of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section 31, Township 20 South, Range 62 East, M.D.B. & M., saving and excepting the North 190 feet thereof.

FROM R-1 to P-R (Z-11-64)

Lot 24, Block 1, Paradise Village Tract No. 1.

FROM R-3 to R-1 (Z-19-64)

Commencing at a point 2286 feet South along the center line of the center of Section 26, Township 20 South, Range 60 East, M.D.B. & M.; thence South 89°55'45" East a distance of 1500.00 feet; thence North 0°13'50" West a distance of 160.00 feet to the true point of beginning; thence North 64°13'50" West a distance of 405.00 feet; thence South 19°59'06" West a distance of 100.79 feet; thence South 64°13'50" East a distance of 439.7 feet; thence North 0°13'50" West to the true point of beginning.

FROM R-3 to R-1 (Z-20-64)

Commencing at the South Quarter corner of Section 26, Township 20 South, Range 60 East, M.D.B. & M.; thence North 0°13'52" West a distance of 866.79 feet to the true point of beginning; thence South 88°19'47" East a distance of 166.51 feet; thence South 0°13'52" East a distance of 132.06 feet; thence South 88°19'47" East a distance of 63.62 feet; thence South 0°13'52" East a distance of 130.07 feet; thence North 88°19'47" West a distance of 225.55 feet; thence North 0°13'52" West a distance of 262.11 feet to the true point of beginning.

FROM R-3 to R-1 (Z-21-64)

Commencing at the South Quarter corner of Section 26, Township 20 South, Range 60 East, M.D.B. & M.; thence North 0°13'52" West a distance of 604.68 feet; thence South 88°19'47" East a distance of 940.98 feet; thence along a curve to the right having a radius of 554.0 feet, a delta of 15°12'38", a tangent length of 73.97 feet, and a curve length of 147.07 feet to a point; thence South 70°00'54" East a distance of 35.50 feet to a point; thence South 64°13'50" East a distance of 439.70 feet to a point; thence South 0°13'50" East a distance of 373.16 feet to a point; thence North 89°55'45" West a distance of 1500.00 feet to the true point of beginning.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

FROM R-1 to R-1 (Z-65-63)

Parcel 13

A portion of the Southwest Quarter
(SW1/4) of Section 30, Township 20 South,
Range 62 East, M.D.B. & M., and be-
ing more particularly described as be-
ginning at the East Quarter corner of
the Southwest Quarter (SW1/4) of said
Section 30; thence South 1130.00 feet;
