

ORDINANCE NO. 934-45

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

FROM R-4 to C-2 (Z-104-63)

Lots 25 through 32, inclusive, Block 9, South Addition.

FROM C-1 to C-2 (Z-126-63)

Lots 21 through 26, inclusive, Block 12, Clark's Las Vegas Townsite.

FROM R-4 to C-2 (Z-128-63)

The West 90.00 feet of Lots 1 through 4, inclusive, Block 27, Clark's Las Vegas Townsite.

FROM R-4 to C-1 (Z-129-63)

Lots 5 and 6, Block 18, South Addition.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub-sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.

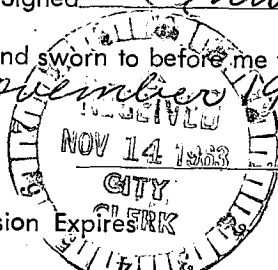
