

ORDINANCE NO. 934-194

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E to R-T (Z-78-70)

The West 257.94 feet of the South 337.76 feet of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section 31, Township 20 South, Range 62 East, MDB&M.

FROM R-1 to C-D (Z-53-70)

Lot 14, Block 1, Westleigh Tract #1.

FROM R-1 to C-D (Z-80-70)

Lot 30, Block 2, Huntridge Subdivision #2.

FROM R-1 to P-R (Z-36-71)

Lot 36, Block 5, Washington Addition #2.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, sub-sections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

FROM R-1 to C-D (Z-53-70) Lot 14, Block 1, Westleigh Tract #1.

FROM R-1 to C-D (Z-80-70) Lot 30, Block 2, Huntridge Subdivision #2.

FROM R-1 to P-R (Z-36-71) Lot 36, Block 5, Washington Addition #2.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed. 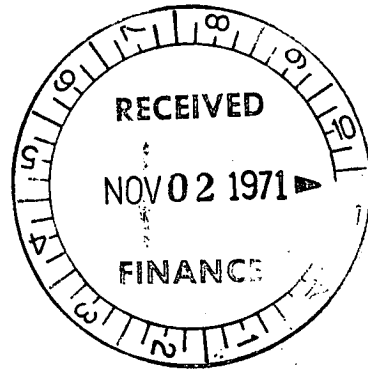
