

ORDINANCE NO. 934-195

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF SAID MAP.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN
AS FOLLOWS:

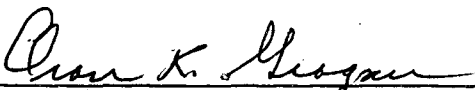
SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

FROM R-E to R-1 (Z-21-71)

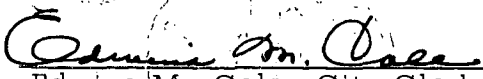
The West Half (W 1/2) of the Southeast Quarter (SE 1/4) of Section 14, Township 20 South, Range 60 East, MDB&M., excepting the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of said Southeast Quarter (SE 1/4) of Section 14.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

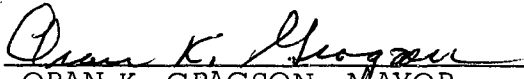

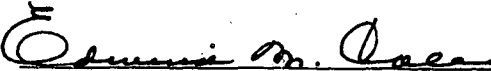

SECTION 1. The Land Use Plan

FROM HEREIN (Z-2170) to
the West Half (W/2) of the
Southeast Quarter (SE/4) of Sec-
tion 14, Township 120 South,
Range 60 East (MDB&M, except-
ing the East Half (E/2) of the
Southeast Quarter (SE/4) of the
Southwest Quarter (SW/4) of
said Southeast Quarter (SE/4) of
Section 14.

subsections, paragraphs, sentences,
clauses or phrases contained in the
Municipal Code of the City of Las
Vegas, Nevada, 1960 Edition, in con-
flict herewith are hereby repealed.

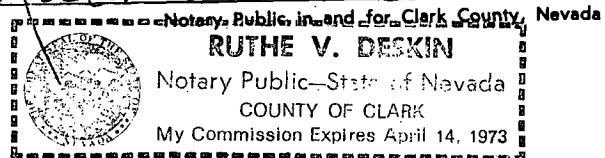
