AN ORDINANCE PERTAINING TO BUSINESS LICENSING; AMENDING TITLE 6, CHAPTER 74, SECTION 50 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY REMOVING TOTAL BAN ON ISSUANCE OF A SECONDHAND DEALER'S LICENSE FOR ANY LOCATION ON FREMONT STREET AND CERTAIN LOCATIONS ON LAS VEGAS BOULEVARD; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Permits locations on Fremont Street and Las Vegas Boulevard South between Charleston Boulevard and Sahara Avenue to be issued a secondhand dealer's license if a variance for such use has been granted pursuant to Title 19 of the City Code.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 74, Section 50 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.74.050: [After the date of the 1981 ordinance codified in this Chapter, no secondhand dealer's license shall be issued to any location on Fremont Street or on Las Vegas Boulevard South between Charleston Boulevard and Sahara Avenue.]

A secondhand dealer's license must not be issued to a location on Fremont Street or on Las Vegas Boulevard South between Charleston Boulevard and Sahara Avenue, unless a variance has been granted, in accordance with the provisions of Title 19, permitting such use at that location.

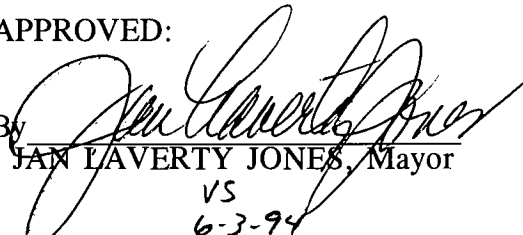
SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses

1 or phrases be declared unconstitutional, invalid or ineffective.

2 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
3 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
4 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

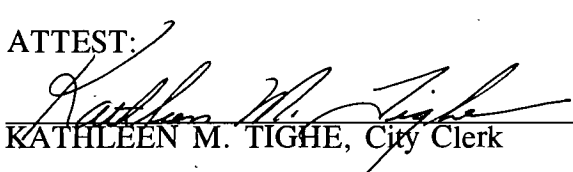

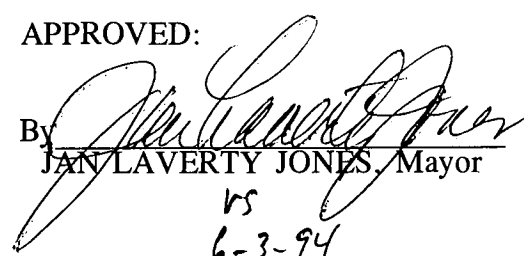

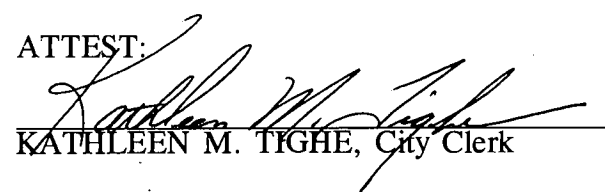
