Summary: Authorizes the summary
abatement of certain nuisance conditions on
vacant lots.

9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
10 ORDAIN AS FOLLOWS:

11 SECTION 1: Title 9, Chapter 4, of the Municipal Code of the City of Las
12 Vegas, Nevada, 1983 Edition, is hereby amended by adding a new section to read as follows:

13 On any vacant lot, the existence of any of the nuisance conditions described in
14 Subsections (N) and (P) of Section 9.04.030 poses a potential threat to public
15 safety, results in deterioration and blighting of the surrounding area, has an adverse
16 effect on the use and enjoyment of nearby properties, and is therefore harmful to
17 the health, safety and welfare of the community. The City may provide for the
18 summary removal or abatement of such nuisances without prior notice and at the
19 City's expense.

20 SECTION 2: Title 9, Chapter 4, Section 30, of the Municipal Code of the
21 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

22 9.04.030: The following matters, things, substances, acts and conditions are nuisances and
23 are prohibited:

24 (A) Any adult-oriented bookstore or adult-oriented movie theater which
25 holds for production, publication, sale or exhibition, obscene items, as defined in Section
26 10.42.010;

1 (B) The commission of any act within the corporate limits of the City
2 or failure to perform any act within such corporate limits which is made a nuisance by the laws
3 of the State of Nevada shall constitute a misdemeanor;

4 (C) Any and all putrid or decaying carcasses, flesh, fish, vegetables,
5 entrails, offal, filth, or other unwholesome or offensive substances of any kind left, deposited or
6 existing upon any street, alley, private lot or ground or public place or in or about any vacant or
7 occupied building, except when enclosed in a receptacle as provided in Chapter 9.08;

8 (D) Any deposit or pile of manure except where it is kept in a box or
9 other receptacle which is covered or screened so as not to be exposed to flies;

10 (E) All filthy water thrown or drained upon any street, alley, public or
11 private lot or ground so as to be offensive;

12 (F) All stagnant pools or ponds;

13 (G) Any article or thing placed on and obstructing a street, alley or public
14 ground except as permitted by the provisions of this Code or by resolution. However, nothing
15 in this Chapter prevents the erection or maintenance of fences, railings or guards in parking if
16 they are well-built, kept in repair, have no sharp points or corners and their tops are at least thirty
17 inches above the ground;

18 (H) Any fence, railing, posts or guards having sharp points or comers
19 or in disrepair or having a height less than thirty inches, placed upon or along any park or parking
20 of any street or avenue, or upon private property, along and within three feet of any public
21 sidewalk;

22 (I) The sweeping of the floors of stores, offices or public buildings into
23 the streets, avenues or alleys and the shaking or beating of carpets or rugs of such stores, offices
24 or buildings in or upon the streets, avenues or alleys;

25 (J) The pollution of any well, stream, lake, river or body of water by
26 the dumping or throwing of any sewage, industrial waste, carcass, garbage, refuse, offal or

1 manure, except with the consent and under the direction of the [Health Officer,] Clark County
2 Health District, and the dumping or throwing of any of such items upon any private or public
3 property;

4 (K) The hauling through the streets or alleys of garbage or other matter
5 having offensive odor, except in covered vehicles or receptacles that are tight, clean and kept free
6 from the emission of offensive odors;

7 (L) All noxious weeds, brush, vines, dense or other rank growth upon
8 public or private property;

9 (M) All buildings, walls, and other structures which have been damaged
10 by fire, decay or otherwise, and which are so situated as to endanger the safety of the public or
11 which, because of their condition or appearance, become injurious to the senses or obstruct the
12 free use of property of others;

13 (N) The storage of inflammable junk, such as old rags, rope, cordage,
14 rubber and paper;

15 (O) All open cisterns or cisterns with inadequate or improper and unsafe
16 coverings, open basements, holes, trenches or other excavations not properly marked or made
17 without taking precautionary measures to prevent injury to the public, except under such
18 conditions as are provided by this Code;

19 (P) The depositing or keeping of junk and refuse such as, but not limited
20 to, old lumber, tin, wire, cans, barrels, cartons, boxes, rags, tires, inner tubes, brush, grass and
21 hedge clippings, rocks, bricks, cinders, scrap iron, buckets, tubs, windows, screens, glass,
22 bottles, wastepaper, bedsprings, mattresses, discarded furniture, cleanings and bedding from
23 animal or fowl pens, improperly covered garbage and waste receptacles, automobiles in improper
24 working condition or in a dilapidated condition and old automobile parts.

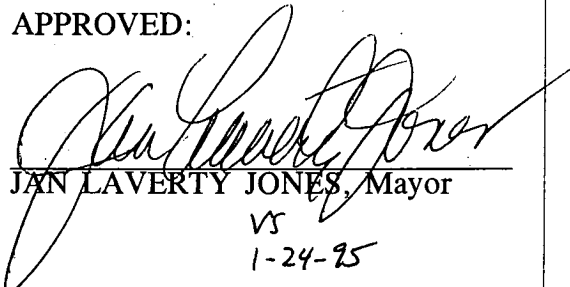
25 SECTION 3: If any section, subsection, subdivision, paragraph, sentence,
26 clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional

1 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
2 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
3 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
4 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
5 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases
6 be declared unconstitutional, invalid or ineffective.

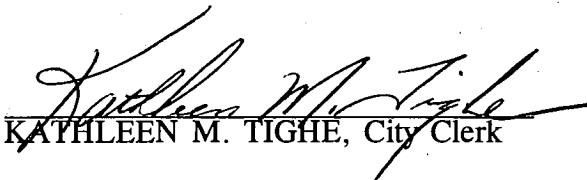
7 SECTION 4: All ordinances or parts of ordinances, sections, subsections,
