20 districts. Such improvements will be extended into the undeveloped areas as development takes
21 place and the need therefor arises, and will be located according to the needs of the area at that
22 time. Such installations will also be made at the expense of the property owners, either by means
23 of special assessment districts or as prerequisites to the approval of subdivision plats or the
24 issuance of building permits, rezonings, zone variances or special use permits.

25 SECTION 4: The annexation of said described territory shall become
26 effective on the 25th day of November, 1994, and on such date the City of Las Vegas will have

1 the funds appropriated in sufficient amount to finance the extension into said described territory
2 of police protection, fire protection, street maintenance, street sweeping, and street lighting
3 maintenance.

4 SECTION 5: Said described territory, together with the inhabitants and
5 property thereof, shall, from and after the 25th day of November, 1994, be subject to all debts,
6 laws, ordinances and regulations in force in the City of Las Vegas and shall be entitled to the
7 same privileges and benefits as other parts of said City, and shall be subject to municipal taxes
8 levied by the City of Las Vegas, Nevada.

9 SECTION 6: The City Engineer of the City of Las Vegas, Nevada, is
10 hereby instructed to cause to be prepared an accurate map or plat of said described territory and
11 to record the same, together with a certified copy of this ordinance in the office of the County
12 Recorder of Clark County, Nevada, which said recording shall be done prior to the 25th day of
13 November, 1994.

14 SECTION 7: The said described territory, which heretofore has been zoned
15 R-E (County of Clark classification), is hereby classified as N-U (City of Las Vegas
16 classification), which is deemed to be the City equivalent of said County classification.

17 SECTION 8: If any section, subsection, subdivision, paragraph, sentence,
18 clause or phrase in this ordinance or any part thereof, is for any reason held to be
19 unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision
20 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part
21 thereof. The City Council of the City of Las Vegas hereby declares that it would have passed
22 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective
23 of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses
24 or phrases be declared unconstitutional, invalid or ineffective.

25 SECTION 9: All ordinances or parts of ordinances, sections, subsections,
26 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las

Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

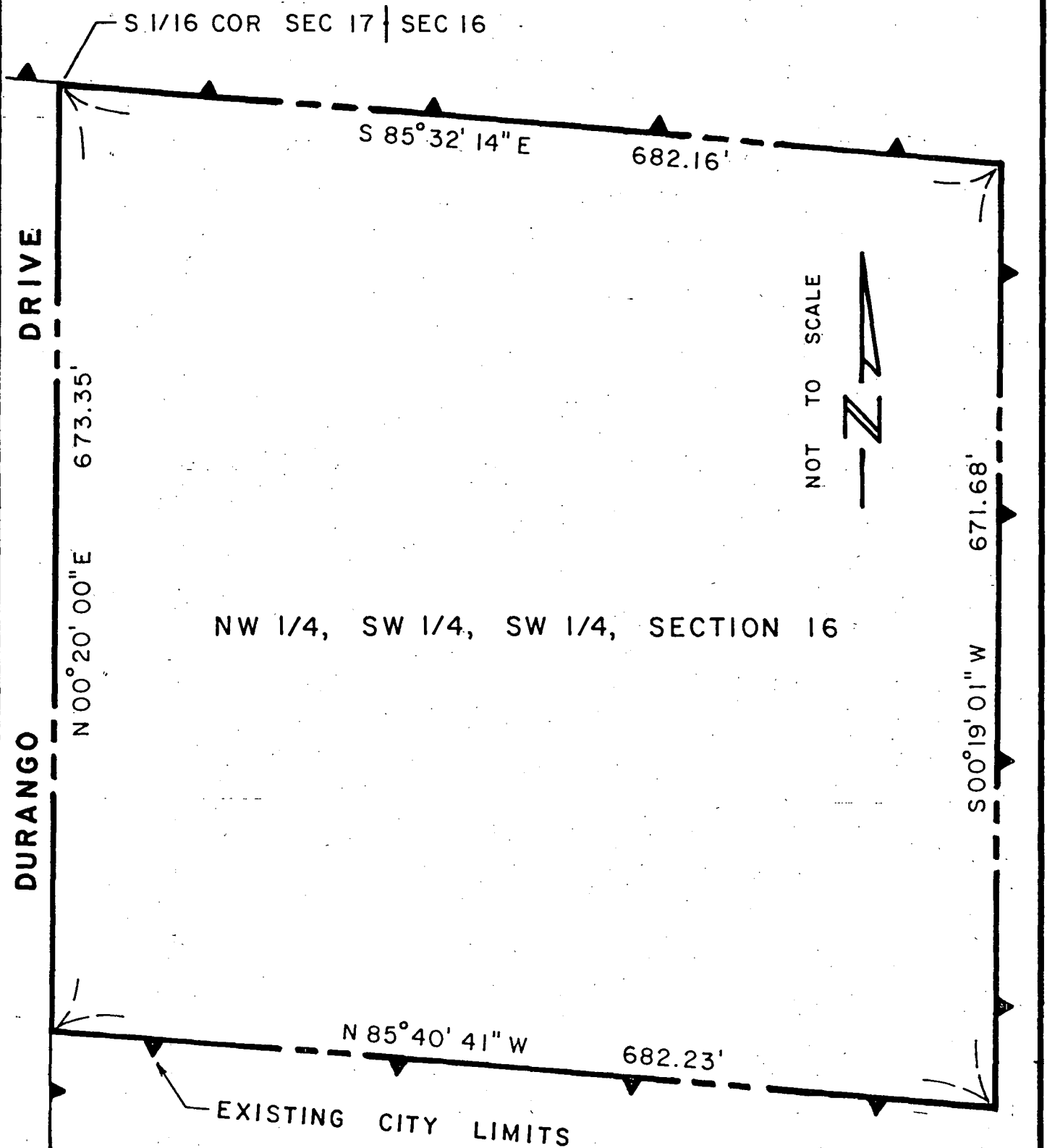

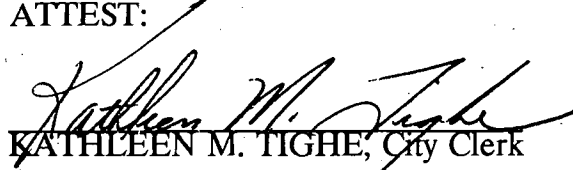
