

ORDINANCE NO. 3848

AN ORDINANCE PERTAINING TO ALCOHOLIC BEVERAGES; AMENDING TITLE 6, CHAPTER 50 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING A NEW SECTION ESTABLISHING THE ALCOHOLIC BEVERAGE BUSINESS LICENSE CATEGORY OF GIFT BASKET LIMITED LICENSE WHICH AUTHORIZES ORIGINAL SEALED OR CORKED CONTAINERS OF ALCOHOLIC BEVERAGES TO BE PACKAGED ALONG WITH ASSORTED FOOD ITEMS AND NOVELTY ITEMS IN A GIFT BASKET FOR RETAIL SALE; AMENDING SECTION 20 OF SAID TITLE AND CHAPTER TO INCLUDE THE DEFINITION OF THE TERM "GIFT BASKET"; AMENDING SECTION 230 OF SAID TITLE AND CHAPTER TO PROVIDE A \$500.00 SEMIANNUAL LICENSE FEE AND A \$2,500.00 ORIGINAL NEW LICENSE FEE FOR A GIFT BASKET LIMITED LICENSE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH.

Summary: Establishes a gift basket limited license which authorizes alcoholic beverages in original sealed or corked containers to be packaged in a gift basket along with food or novelty items.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1. Title 6, Chapter 50 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding a new section reading as follows:

(A) Gift basket limited license authorizes alcoholic beverages in original sealed or corked containers in quantities not greater than 25.4 ounces (approximately 1.79 pints), measured in the English system of weights and measures, or in quantities not greater than seven hundred fifty milliliters, measured in the metric system of weights and measures, to be packaged in a gift basket along with other assorted food items or novelty items, or both, which items have a minimum retail value of thirty-five dollars apart from the retail value of the alcoholic beverages; provided, however:

(1) The contents of the gift baskets are not sold separately but, instead, are included as part of the unit retail sale price of the gift basket; and

(2) The alcoholic beverages are consumed off the premises where

1 the gift basket is sold.

2 (B) Alcoholic beverages shall comprise not more than twenty percent of
3 the total inventory of merchandise located at a premise for which a gift basket limited license has
4 been issued and shall be stored in such a manner that prevents public access.

5 (C) A gift basket limited licensee shall not display any advertising on the
6 exterior of his or her licensed premises of the fact that alcoholic beverages are maintained on the
7 licensed premises from which a customer can choose for the purposes of having the item selected
8 included in a gift basket.

9 (D) A gift basket limited licensee shall not deliver any alcoholic beverage
10 to a personal residence in response to a telephone call requesting such delivery.

11 SECTION 4: Title 6, Chapter 50, Section 020 of the Municipal Code of
12 the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

13 **6.50.020:** (A) "Alcoholic beverage" includes alcohol, spirits, liquor, wine and beer, and
14 every liquid or solid which contains alcohol, spirits, liquor, wine or beer; and which contains one-
15 half of one percent or more of alcohol by volume; and which is fit for beverage purposes, either
16 alone or when diluted, mixed or combined with other substances. Any liquid or solid containing
17 beer or wine in combination with any other alcoholic beverage shall not be construed to be beer
18 or wine.

19 (B) "Beer" means any alcoholic beverage obtained by the fermentation of
20 any infusion or decoction of barley, malt, hops or similar product, or any combination thereof,
21 in water.

22 (C) "Cooler" means any prebottled alcoholic beverage, other than beer or
23 wine, that is a distillate obtained from the fermentation of the natural contents of fruits or other
24 agricultural products containing natural or added sugar, which contains not more than five and
25 seven-tenths percent of alcohol by volume.

26 (D) "Drug store" means a business which has a registered pharmacist in

1 attendance at all times and which is located in a building, or in a portion of a building which is
2 segregated physically or spatially from the rest of the building, selling at retail a stock of
3 merchandise having a retail value of at least thirty thousand dollars, of which at least sixty percent
4 consists of prescription and non-prescription drugs and medicines, remedies and devices for use
5 in curing or preventing human ailments and diseases and alleviating pain, other pharmaceuticals,
6 items associated with personal hygiene, cosmetics, notions and sundries, and having at least one
7 thousand two hundred square feet of floor space, exclusive of warehouse and office areas, devoted
8 to the display of such stock of merchandise. No more than twenty-five percent of a drug store's
9 retail inventory shall consist of beer, wine, cooler and tobacco products.

10 (E) "Gift basket" means a receptacle or container commonly made of
11 interwoven wicker material, or material that resembles wicker, that may be filled with food items
12 or novelty items, and alcoholic beverages in sealed or corked containers in quantities not greater
13 than 25.4 ounces (approximately 1.79 pints), measured in the English system of weights and
14 measures, or in quantities not greater than seven hundred fifty milliliters measured in the metric
15 system of weights and measures; provided, however, alcoholic beverages shall not be included
16 unless one or more food items or novelty items, or both, having a minimum retail value of thirty-
17 five dollars, are also included in the gift basket.

18 [(E)](F) "Grocery Store" means a business located in a building, or in a
19 portion of a building which is segregated physically or spatially from the rest of the building,
20 selling at retail a stock of merchandise having a retail value of at least thirty thousand dollars, of
21 which at least sixty percent consists of articles for human consumption customarily served as food
22 in the home or entering into the preparation of food in the home, and having at least one thousand
23 two hundred square feet of floor space, exclusive of warehouse and office areas, devoted to the
24 display of such stock of merchandise. No more than twenty-five percent of a grocery store's
25 retail inventory shall consist of beer, wine and tobacco products.

26 [(F)](G) "Liquor caterer" means a person who dispenses, serves or sells

1 alcoholic beverages only for consumption on the premises where the same are dispensed, served
2 or sold during the times and periods specified by permit; provided, however, a caterer's services
3 are performed between diverse locations on a shifting and intermittent basis as opposed to a
4 permanent location.

5 [(G)](H) "Malt beverage" means beer, ale, porter, stout and other similar
6 fermented beverages of any name or description, brewed or produced from malt, wholly or in
7 part.

8 [(H)](I) "Meals" means the usual assortment of foods commonly ordered
9 at various hours of the day; provided, however, that the service of such food only as sandwiches
10 and salads shall not be deemed a compliance with this requirement.

11 [(I)](J) "Nonprofit club" means any nonprofit corporation, nonprofit
12 association or nonprofit organization which is organized or qualified to do business and operating
13 under the laws of the State; and which has and maintains tax-exempt status granted by the United
14 States Internal Revenue Service; and which has at the time of application for a license and
15 maintains continuously thereafter a bona fide membership of at least one hundred dues-paying
16 members over the age of twenty-one years; and which has been in continual existence for at least
17 two years prior to the application for the license; and which owns or leases and operates or
18 maintains a clubhouse, clubroom or meeting room in a permanent location.

19 [(J)](K) "Off-sale" means the sale of beer, wine and coolers in original
20 sealed or corked containers for consumption off the premises where the same are sold.

21 [(K)](L) "On-sale" means the sale of beer, wine and coolers for
22 consumption on the premises where the same are sold.

23 [(L)](M) "Restaurant" means a place which is regularly and in a bona fide
24 manner used and kept open for the service of meals to guests for compensation; and which has
25 suitable kitchen facilities connected therewith, containing convenience for cooking an assortment
26 of foods which may be required for ordinary meals.

1 [(M)](N) "Restaurant service bar" means a bar wherein alcoholic beverage
2 drinks are prepared for service only at tables in a restaurant for consumption only in connection
3 with a meal on the premises where the same is sold and where customers are not permitted to
4 purchase alcoholic beverage drinks directly from such bar.

5 [(N)](O) "Sale" or "sell" means, for compensation or any other business
6 purpose, to sell, serve, give away or distribute; or to cause or permit to be sold, served, given
7 away or distributed or to possess with the intent to sell, serve, give away or distribute; or to
8 solicit or receive orders to sell, serve, give away or distribute.

9 [(O)](P) "Supper club" means a restaurant and bar operation with alcoholic
10 beverage sales wherein the minimum seating capacity of the restaurant and the actual seating
11 available at all times will accommodate one hundred or more persons for full-course meals,
12 wherein the bar area is separated from the restaurant area by a barrier sufficient to prevent access
13 thereto by minors, and wherein the restaurant operation is the principal portion of the business.

14 [(P)](Q) "Wholesale dealer" or "wholesaler" means a person who sells
15 alcoholic beverages for the purposes of resale.

16 [(Q)](R) "Wine" means any alcoholic beverage, other than beer, obtained
17 by the fermentation of the natural contents of fruits or other agricultural products containing
18 natural or added sugar, which contains not more than twenty-two percent of alcohol by volume.

19 SECTION 5: Title 6, Chapter 50, Section 230 of the Municipal Code of

Each special event general licensee shall pay a license fee of fifty dollars per day.

Each special event beer/wine/cooler licensee shall pay a license fee of twenty-five dollars per day.

SECTION 6: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 7: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

5 alcoholic beverages are maintained on the licensed premises from which a customer can choose

7 SECTION 4: Title 6, Chapter 50, Section 020 of the Municipal Code of
8 the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

9 **6.50.020:** (A) "Alcoholic beverage" includes alcohol, spirits, liquor, wine and beer, and
10 every liquid or solid which contains alcohol, spirits, liquor, wine or beer; and which contains one-
11 half of one percent or more of alcohol by volume; and which is fit for beverage purposes, either
12 alone or when diluted, mixed or combined with other substances. Any liquid or solid containing
13 beer or wine in combination with any other alcoholic beverage shall not be construed to be beer
14 or wine.

19 [(L)](M) "Restaurant" means a place which is regularly and in a bona fide
20 manner used and kept open for the service of meals to guests for compensation; and which has
21 suitable kitchen facilities connected therewith, containing convenience for cooking an assortment
22 of foods which may be required for ordinary meals.

23 [(M)](N) "Restaurant service bar" means a bar wherein alcoholic beverage
24 drinks are prepared for service only at tables in a restaurant for consumption only in connection
25 with a meal on the premises where the same is sold and where customers are not permitted to
26 purchase alcoholic beverage drinks directly from such bar.

1 [(N)](O) "Sale" or "sell" means, for compensation or any other business
2 purpose, to sell, serve, give away or distribute; or to cause or permit to be sold, served, given
3 away or distributed or to possess with the intent to sell, serve, give away or distribute; or to
4 solicit or receive orders to sell, serve, give away or distribute.

5 [(O)](P) "Supper club" means a restaurant and bar operation with alcoholic
6 beverage sales wherein the minimum seating capacity of the restaurant and the actual seating
7 available at all times will accommodate one hundred or more persons for full-course meals,
8 wherein the bar area is separated from the restaurant area by a barrier sufficient to prevent access
9 thereto by minors, and wherein the restaurant operation is the principal portion of the business.

10 [(P)](Q) "Wholesale dealer" or "wholesaler" means a person who sells
11 alcoholic beverages for the purposes of resale.

12 [(Q)](R) "Wine" means any alcoholic beverage, other than beer, obtained
13 by the fermentation of the natural contents of fruits or other agricultural products containing
14 natural or added sugar, which contains not more than twenty-two percent of alcohol by volume.

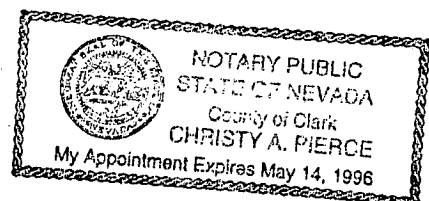
