ORDINANCE NO. 3899

AN ORDINANCE RELATING TO SEWER SERVICE SURCHARGES; AMENDING TITLE 14, CHAPTER 4, SECTION 160, OF THE CITY OF LAS VEGAS, NEVADA, MUNICIPAL CODE, 1983 EDITION, TO REDUCE THE AMOUNT OF THE SURCHARGE FROM \$2.30 TO \$2.01 PER EQUIVALENT RESIDENTIAL UNIT; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Reduces rate per equivalent residential unit from \$2.30 to \$2.01 for sewer service surcharges.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 14, Chapter 4, Section 160, of the City of Las Vegas, Nevada, Municipal Code, 1983 Edition, is hereby amended to read as follows:

14.04.160: There is established and imposed upon the customers of the City's sewage disposal system, effective as of July 1, [1992] 1995 a surcharge in the amount of [two dollars and thirty cents] two dollars and one cent per equivalent residential unit. Each customer shall pay to the City annually, as his, her or its proportionate share of the service surcharge due from the City to Clark County pursuant to Clark County Ordinance No. 730, an amount equal to [two dollars and thirty cents] two dollars and one cent multiplied by the number of equivalent residential units charged to such customer. The surcharge shall be billed annually to each customer of the City's sewage disposal system, including those customers whose properties are hereafter connected thereto, at the same time as the customer's regular sewer service charge and shall apply to the calendar year in which it is billed; provided, however, that the amount of such surcharge may hereafter be adjusted from time to time to reflect any change effected by Clark County in such service charge pursuant to Section 4(B) to 4(D), inclusive, of Clark County Ordinance No. 730.

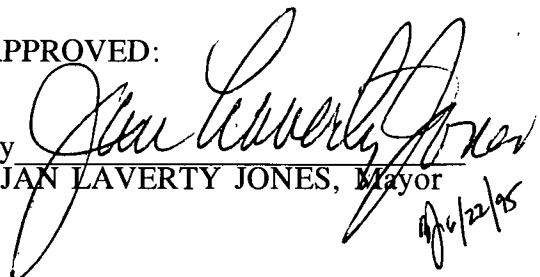
SECTION 2: If any section, subsection, subdivision, paragraph, sentence,

1 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
2 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
3 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
4 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
5 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
6 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
7 declared unconstitutional, invalid or ineffective.

8 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
9 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
10 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

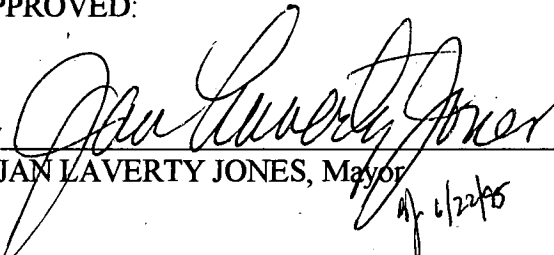

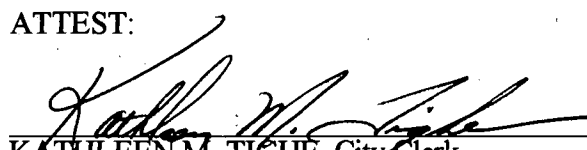

Supplemental Budget Request
Making Municipal Court a Court of Record
1995 - 1996

1. 6 dual head, four track recorders
Sony/\$2,150 ea.
Lanier/\$3,000 ea.
2. 1 duplicator/reformater

5. Installation of audio system: Communication Specialists, Inc. (installed and maintains County system) per a verbal quote from the owner would charge \$700 to \$1,000 per courtroom depending on whether or not we use a "mixer" to allow volume adjustment.

8. Witness Fees would amount to approximately \$60,800 per year. However it is estimated that at the present time approximately \$800 to \$1,000 per week is lost in district court appeals. This means a loss of fines to the City of approximately \$41,600 to \$52,000 per year. Therefore, the net cost for witness fees factoring in the increase in fines would be between \$7,000 and \$20,000 per year. Further, since there will be less incentive for a criminal defendant to ask for a trial in Municipal Court, more cases will be called off before trial obviating the need to pay any witness fees in that case.
9. Transcripts - cost averages \$45 per hour or \$8 per page. Budget would have to include any transcript requested by the City Attorney's office as well as those requested by indigents. The total number is difficult to estimate, however, using Reno as a guide (we have approximately 4 times the number of trials as Reno), we would be paying approximately \$14,400 per year.
