ORDINANCE NO. 3898

AN ORDINANCE RELATING TO BUSINESS LICENSES; AMENDING TITLE 6, CHAPTER 2, SECTION 250, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, TO INCREASE THE ASSESSED PENALTY CHARGE FOR PAYMENT OF LICENSE FEE AFTER FIFTEEN DAYS AFTER THE DUE DATE FROM FIVE PERCENT TO FIFTEEN PERCENT; TO ELIMINATE THE TEN PERCENT LICENSE REINSTATEMENT FEE FOR THOSE LICENSES DEEMED EXPIRED DUE TO NON-PAYMENT OF LICENSE FEE WITHIN THIRTY DAYS OF DUE DATE; TO REQUIRE PAYMENT OF LICENSE FEE AND ASSESSED PENALTY CHARGE AS CONDITION FOR REINSTATING EXPIRED LICENSE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Increases the assessed penalty charge from five percent to fifteen percent for business license fee paid after fifteen days after the due date; requires the same to be paid in addition to regular license fee in order to reinstate license deemed expired due to nonpayment of license fee within thirty days of due date; and eliminates the ten percent reinstatement fee currently charged to reinstate a license deemed to have expired under the above circumstances.

SECTION 1: Title 6, Chapter 2, Section 250, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.02.250: (A) All licenses other than gambling and liquor licenses shall become delinquent if the license fee is not paid within fifteen days after the due date. If payment is made after fifteen days [and before thirty days] after the due date, [five] fifteen percent of the license fee shall be assessed as a penalty charge.

(B) All licenses for which fees and assessed penalty charges have not been paid within thirty days after the due date shall be deemed to have expired. Any such license shall not be reinstated until [the five-percent penalty fee and a ten-percent reinstatement fee have been paid, in addition to the regular license fee.] the license fee and assessed penalty charge have been paid.

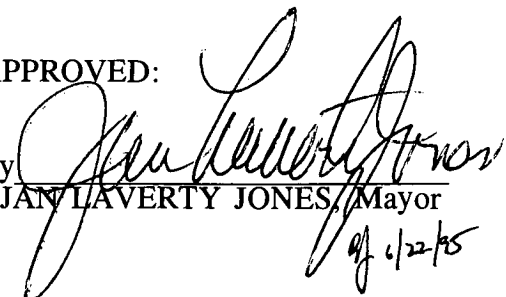
SECTION 2: If any section, subsection, subdivision, paragraph, sentence,

1 clause or phrase in this ordinance or any part thereof, is for any reason held to be
2 unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision
3 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part
4 thereof. The City Council of the City of Las Vegas hereby declares that it would have passed
5 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective
6 of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses
7 or phrases be declared unconstitutional, invalid or ineffective.

8 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
9 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
10 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

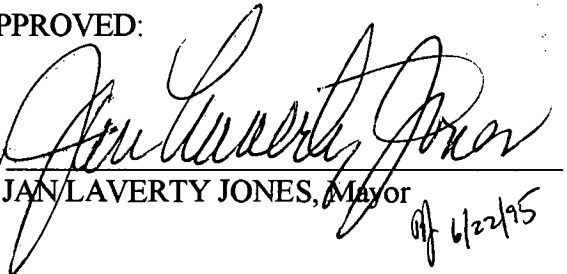

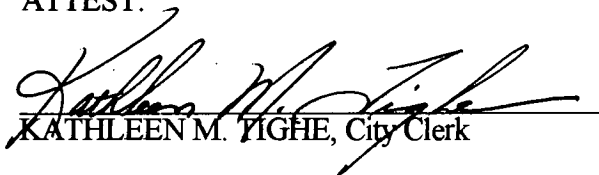
