6 TO TWELVE MONTHS; ALLOWING FOR MORE THAN ONE WEAPON TO BE
7 INCLUDED ON EACH PERMIT; PROVIDING FOR OTHER MATTERS PROPERLY
8 RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF

Summary: Amends Title 10, Chapter 68
relating to concealed weapons permits.

12 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
13 FOLLOWS:

14 SECTION 1: Title 10, Chapter 68 of the Municipal Code of the City of Las
15 Vegas, Nevada, 1983 Edition is hereby amended as follows:

16 **10.68.010 Required.** No person, except a peace officer, shall wear or in any
17 manner carry concealed upon his person any loaded or unloaded gun, pistol or revolver, or any
18 other dangerous or deadly weapon permitted to be carried by law without having, at the same
19 time, actually in his possession and upon his person, an unexpired permit so to do issued by the
20 Sheriff of the Metropolitan Police Department or his designee.

21 **10.68.020 Issuance -- Term -- Content.** (A) The Sheriff of the
22 Metropolitan Police Department or his designee shall have the power to issue to any person who,
23 in the judgment of the Sheriff or his designee, shall have such privilege, a written permit to carry
24 concealed any of the weapons specified hereunder. Such permits shall be numbered consecutively
25 in the order in which they are issued.

26 [(B) No permit shall be granted for a longer period than twelve months.]

[(C)](B) Each such permit shall state the name, address and occupation of the
person to whom the same is issued, and the date of its expiration and shall specify the kind and

1 description of [weapon] *weapons* authorized to be carried concealed by such person.

2 **10.68.030 Records -- Fee.** (A) The Sheriff of the Metropolitan Police
3 Department or his designee shall keep a record of all persons to whom a permit has been
4 authorized by him hereunder.

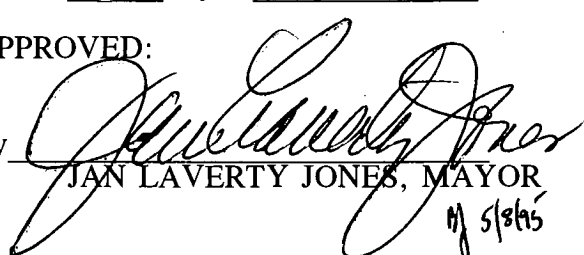
5 (B) No permit required hereunder shall be issued to any person until such person
6 shall have paid to the Sheriff or his designee a registration fee of three dollars. On Monday of
7 each week the Sheriff or his designee shall pay to the City Treasurer all such fees received during
8 the preceding week.

9 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause
10 or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or
11 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
12 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
13 Council of the City of Las Vegas hereby declares that it would have passed each section,
14 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
15 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
16 declared unconstitutional, invalid or ineffective.

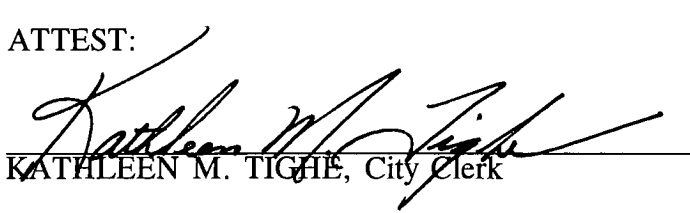
17 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
18 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
19 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

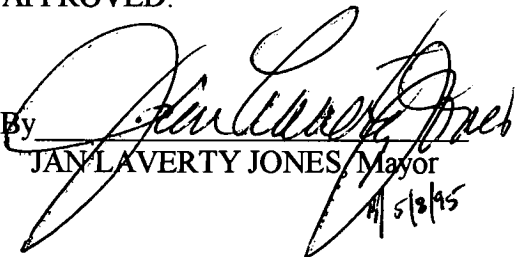

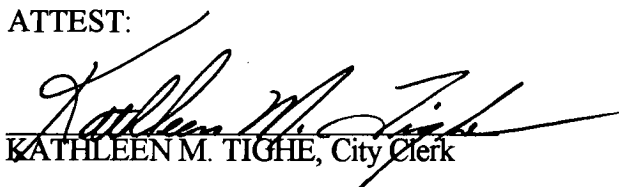
