12 SECTION 1: Title 6, Chapter 4, of the Municipal Code of the City of Las
13 Vegas, Nevada, 1983 Edition, is hereby amended by adding a section thereto reading as follows:

14 For each factory, plant and industry that is physically located within City
15 limits, engaged in mining, milling or manufacturing, the semiannual license

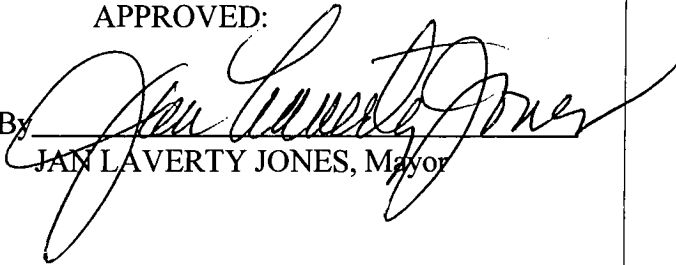
21 SECTION 2: If any section, subsection, subdivision, paragraph, sentence,
22 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
23 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
24 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
25 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
26 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that

any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 3: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

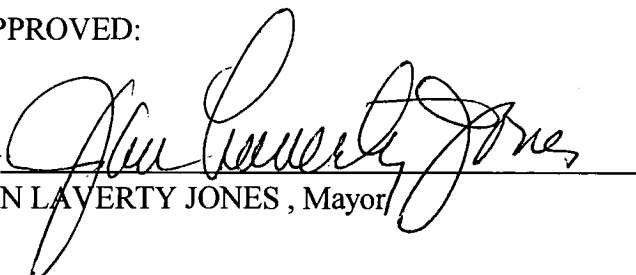

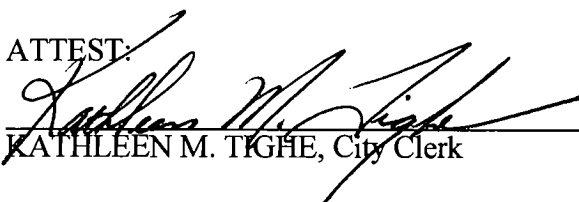
