12 ORDAIN AS FOLLOWS:

13 SECTION 1: Title 6, Chapter 46, Section 30, of the Municipal Code of the
14 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

15 **6.46.030:** Each operator shall pay semiannual license fees per the following schedule:

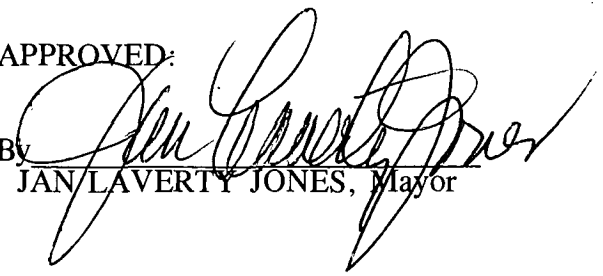

5 to 8	\$ 25.00
9 to 18	25.00
51 to 80	100.00
81 to 120	125.00
121 to 160	150.00
161 to 200	175.00
201 to 250	200.00
251 to 300	225.00
301 to 350	250.00
351 to 400	275.00
401 to 450	300.00
451 to 500	325.00
Over 500	325.00 plus \$.50 for each room in excess of 500.]
<u>9 to 300</u>	<u>3.00 for each room</u>
<u>over 300</u>	<u>900.00 plus \$1.50 for each</u> <u>room over 300.</u>

1 SECTION 2: If any section, subsection, subdivision, paragraph, sentence,
2 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
3 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
4 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
5 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
6 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
7 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
8 declared unconstitutional, invalid or ineffective.

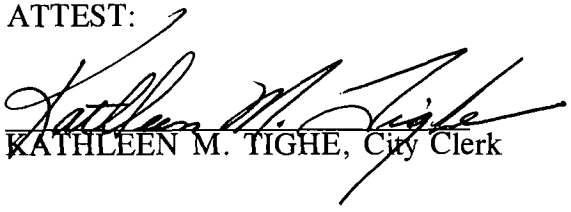
9 SECTION 3: All ordinances or parts of ordinances, sections, subsections,

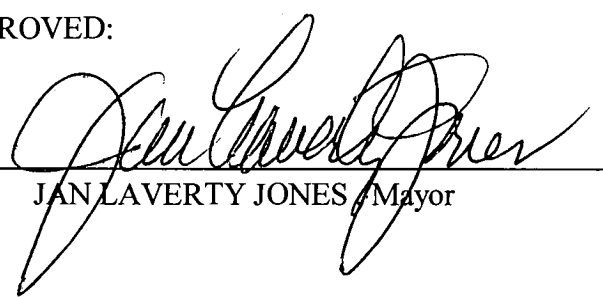

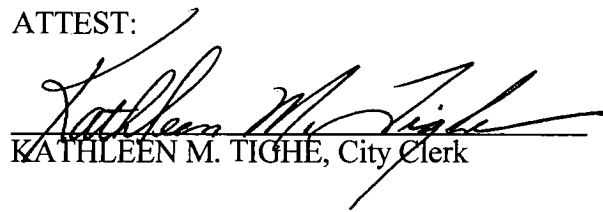
