25 area. Any connection to or extension of this sewer line to serve
26 the annexation area shall be at the expense of the landowners.
27 Other services, such as participation in the City's recreational
28 programs, special education classes and programs, public works
29 planning, building inspections, and other City Hall services will
30 also be available immediately. Utilities such as gas, electri-
31 city, telephone, and water are provided by private utility com-
32 panies and other services to the area will not be affected by

1 annexation. Street paving, curbs and gutters, sidewalks and
2 street lights which are not in place at the time of annexation
3 will be installed in the presently developed areas upon the
4 request of the property owners and at their expense by means of
5 special assessment districts. Such improvements will be extended
6 into the undeveloped areas as development takes place and the
7 need therefor arises, and will be located according to the needs
8 of the area at that time. Such installations will also be made
9 at the expense of the property owners, either by means of special
10 assessment districts or as prerequisites to the approval of sub-
11 division plats or the issuance of building permits, re-zonings,
12 zone variances or special use permits.

13 SECTION 4: The annexation of said described territory
14 shall become effective on the 28th day of September, 1990, and on
15 such date the City of Las Vegas will have the funds appropriated
16 in sufficient amount to finance the extension into said described
17 territory of police protection, fire protection, street main-

 2 hereby classified as N-U (City of Las Vegas classification),
 3 which is deemed to be the City equivalent of said County classi-
 4 fication..

5 SECTION 8: If any section, subsection, subdivision,
 6 paragraph, sentence, clause or phrase in this ordinance or any
 7 part thereof, is for any reason held to be unconstitutional, or
 8 invalid or ineffective by any court of competent jurisdiction,
 9 such decision shall not affect the validity or effectiveness of
 10 the remaining portions of this ordinance or any part thereof.
 11 The City Council of the City of Las Vegas hereby declares that it
 12 would have passed each section, subsection, subdivision,
 13 paragraph, sentence, clause or phrase thereof irrespective of the
 14 fact that any one or more sections, subsections, subdivisions,

 16 tional, invalid or ineffective.

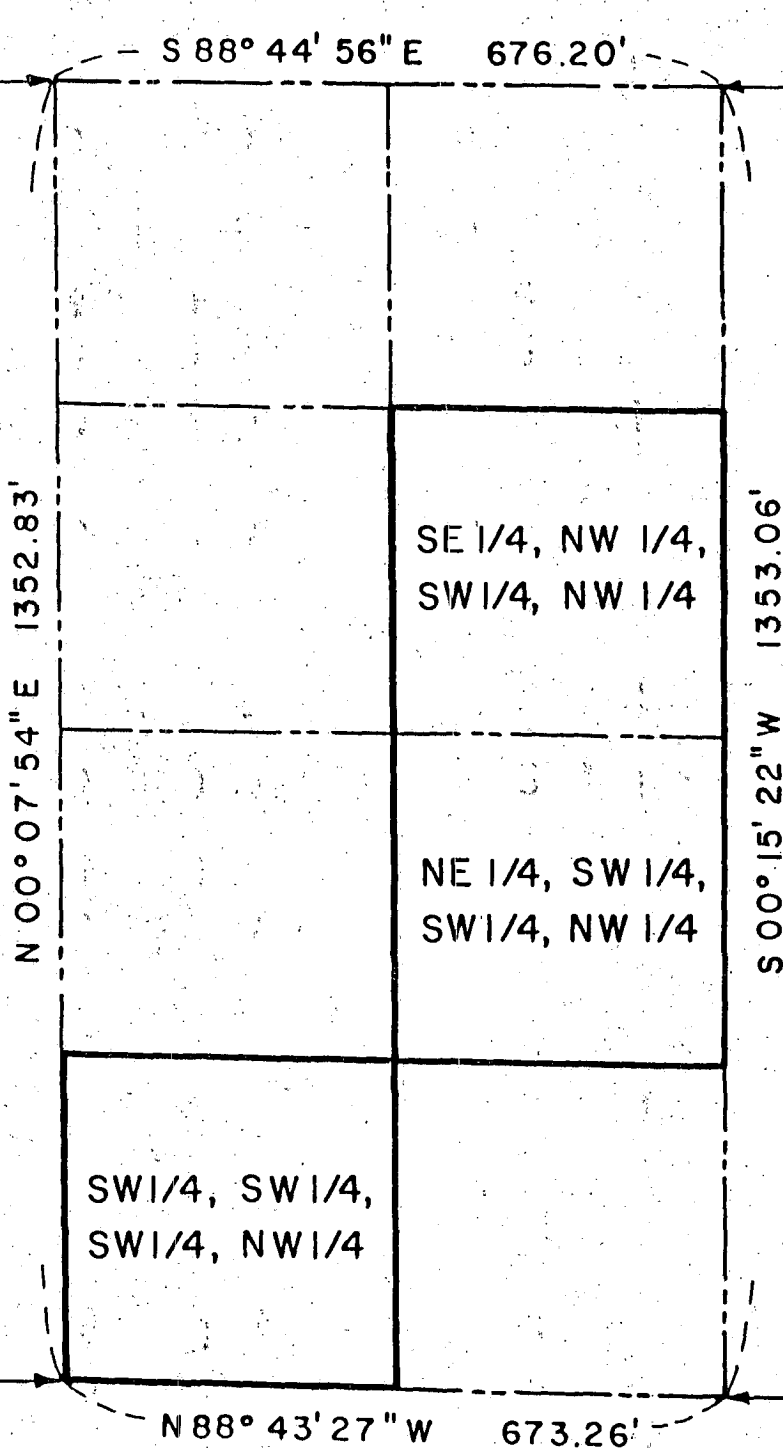
