AN ORDINANCE RELATING TO ANIMAL CONTROL; REPEALING TITLE 7, CHAPTER 4, SECTION 100, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION; AMENDING CHAPTER 16 OF SAID TITLE BY ADDING THERETO A NEW SECTION, DESIGNATED AS SECTION .5, WHICH MAKES IT UNLAWFUL FOR ANY PERSON TO CAUSE OR PERMIT ANY ANIMAL TO RUN AT LARGE WITHIN THE CORPORATE BOUNDARIES OF SAID CITY; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Amends Animal Control Ordinance to make it clear that permitting animals to run at large is unlawful.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 16, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new Section, to be designated as Section .5, reading as follows:

7.16.005: It is unlawful for any person who owns or has the possession, charge, custody or control of any animal to cause, permit or allow such animal to be off their premises, to run at large, that is, the animal is off the property of the person who owns or has custody of the animal and is in or upon any public street, sidewalk, or park or upon any unenclosed lot or parcel of real property, whether publicly or privately owned by someone other than the animal owner, within the corporate boundaries of the City and the animal is not constrained by a leash, rope, or chain or under the immediate control of the owner or the person who has custody of said

1 animal.

2 SECTION 2: Title 7, Chapter 16, Section 30, of the
3 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
4 hereby amended to read as follows:

5 7.16.030: [(A) It shall be unlawful to permit any dangerous,
6 vicious or ferocious animal to run at large in the
7 City.

8 (B)] Exhibitions or parades of animals which are
9 dangerous, ferocious, vicious, or wild, may be
10 conducted only upon securing a permit from the
11 Sheriff.

12 SECTION 3: Title 7, Chapter 4, Section 100, of the
13 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
14 hereby repealed in its entirety.

15 SECTION 4: If any section, subsection, subdivision
16 paragraph, sentence, clause or phrase in this ordinance or any
17 part thereof, is for any reason held to be unconstitutional or
18 invalid or ineffective by any court of competent jurisdiction,
19 such decision shall not affect the validity or effectiveness of
20 the remaining portions of this ordinance or any part thereof.
21 The City Council of the City of Las Vegas, Nevada, hereby
22 declares that it would have passed each section, subsection, sub-
23 division, paragraph, sentence, clause or phrase thereof,
24 irrespective of the fact that any one or more sections, subsec-
25 tions, subdivisions, paragraphs, sentences, clauses or phrases be
26 declared unconstitutional, invalid or ineffective.

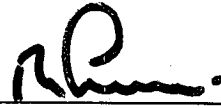
27 SECTION 5: Whenever in this ordinance any act is prohi-
28 bited or is made or declared to be unlawful or an offense or a
29 misdemeanor, or whenever in this ordinance the doing of any act
30 is required or the failure to do any act is made or declared to
31 be unlawful or an offense or a misdemeanor, the doing of any such
32 prohibited act or the failure to do any such required act shall

1 constitute a misdemeanor and upon conviction thereof, shall be
2 punished by a fine of not more than \$1,000.00 or by imprisonment
3 for a term of not more than six months, or by any combination of
4 such fine and imprisonment. Any day of any violation of this
5 ordinance shall constitute a separate offense.

6 SECTION 6: All ordinances or parts of ordinances, sec-
7 tions, subsections, phrases, sentences, clauses or paragraphs
8 contained in the Municipal Code of the City of Las Vegas, Nevada,
9 1983 Edition, in conflict herewith are hereby repealed.

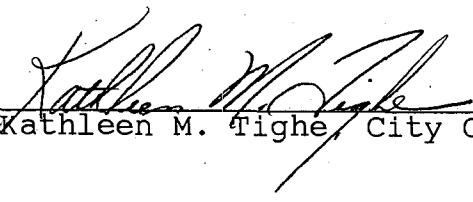
