ORDINANCE No. 3535

AN ORDINANCE RELATING TO PARKING EXEMPTIONS AMENDING TITLE 11, CHAPTER 54, SECTION 190 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY INCREASING THE FEE FOR EXEMPT PERMITS FROM \$2.00 to \$25.00 PER PERMIT; REDUCING THE ALLOWABLE PARKING TIME FROM FOUR HOURS TO TWO HOURS; ALLOWING OWNERS AND OPERATORS OF EXEMPT-PLATED VEHICLES THE SAME PARKING PRIVILEGES WITHOUT THE REQUIREMENT OF PURCHASING OR DISPLAYING AN EXEMPT PARKING PERMIT; ALLOWING EXEMPT-PLATED VEHICLES TO PARK, WITHOUT VIOLATION, FOR A MAXIMUM OF TWO HOURS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Increases exempt permits from \$2.00 to \$25.00 per permit, reduces allowable parking time from four hours to two hours, allows vehicles with exempt plates the same parking privileges as holders of exempt parking permits and allows exempt-plated vehicles to park without violation for a maximum of two hours.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 11, Chapter 54, Section 190, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.54.190: (A) Parking exemption permits shall authorize the persons to whom they are issued to park, without violation, the vehicles to which the permits are affixed in any parking space adjacent to a street parking meter other than a short-term parking meter (12, 15 and 30 minutes) or in any space in a one-hour [or two-hour] time-limited parking zone, while actually engaged in field work, subject to the limitations in Subsection (C) of this Section.

(B) The following groups of persons shall be eligible for parking exemption permits upon application to the City Manager or his authorized designee:

(1) Members of news media whether involved in

1 television, radio or newspaper news preparation or reporting,
2 who are actually in the field preparing or reporting news
3 stories for their employers;

4 (2) Public officials and employees of
5 Federal, State, or local governments who are required by
6 their employers to use [government-owned or] private automo-
7 biles while actually engaged in field work or business out-
8 side of their normal offices.

9 (C) No parking exemption permit shall be approved by
10 the City Manager under this Section unless he receives a
11 letter accompanying the application from the applicant's
12 supervisor describing such applicant's job responsibilities
13 and his need for an exempt parking permit and which shows to
14 the City Manager's satisfaction that the employee qualifies
15 for the permit.

16 (D) A fee of [two] twenty-five dollars shall be charged
17 for each parking exemption permit issued. The fee shall
18 accompany the parking permit request form. If a parking
19 exemption permit is denied, the money shall be refunded.

20 (E) Once a parking exemption permit is issued to a
21 qualified applicant, it shall be unlawful for such person to
22 use the permit for other than official business, and in no
23 case shall the permit authorize any vehicle to park in any
24 space adjacent to a street parking meter or in any space
25 posted one [or two] hour time-limited parking zone for more
26 than [four] two hours continuously.

27 (F) Owners and operators of exempt-plated vehicles
28 shall not be required to apply for, purchase, or display
29 parking exemption permits. Vehicles displaying such license
30 plates shall be authorized to park in any space adjacent to
31 a street parking meter other than a short-term parking meter
32 or in any space posted as a one or two hour time-limited

1 parking zone for not more than two hours continuously.

2 SECTION 2: If any section, subsection, subdivision,
3 paragraph, sentence, clause or phrase in this ordinance or any
4 part thereof, is for any reason held to be unconstitutional or
5 invalid or ineffective by any court of competent jurisdiction,
6 such decision shall not affect the validity or effectiveness of
7 the remaining portions of this ordinance or any part thereof.
8 The City Council of the City of Las Vegas, Nevada, hereby
9 declares that it would have passed each section, subsection, sub-
10 division, paragraph, sentence, clause or phrase thereof irrespec-
11 tive of the fact that any one or more sections, subsections, sub-
12 divisions, paragraphs, sentences, clauses or phrases be declared
13 unconstitutional, invalid or ineffective.

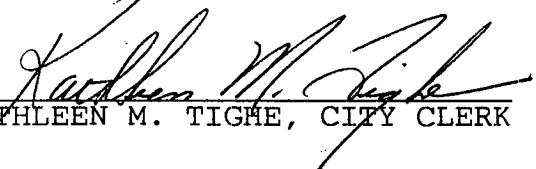
14 SECTION 3: All ordinances or parts of ordinances,

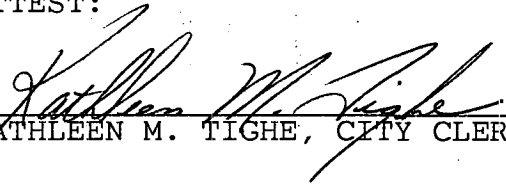

SECTION 1: Title 11, Chapter 54, Section 190, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.54.190: (A) Parking exemption permits shall authorize the persons to whom they are issued to park, without violation, the vehicles to which the permits are affixed in any parking space adjacent to a street parking meter other than a short-term parking meter (12, 15 and 30 minutes) or in any space in a one-hour [or two-hour] time-limited parking zone, while actually engaged in field work, subject to the limitations in Subsection (C) of this Section.

(B) The following groups of persons shall be eligible for parking exemption permits upon application to the City Manager or his authorized designee:

(1) Members of news media whether involved in television, radio or newspaper news preparation or reporting,

1 who are actually in the field preparing or reporting news
2 stories for their employers;

3 (2) Public officials and employees of
4 Federal, State, or local governments who are required by
5 their employers to use [government-owned or] private automo-
6 biles while actually engaged in field work or business out-
7 side of their normal offices.

8 (C) No parking exemption permit shall be approved by
9 the City Manager under this Section unless he receives a

4 invalid or ineffective by any court of competent jurisdiction,
5 such decision shall not affect the validity or effectiveness of
6 the remaining portions of this ordinance or any part thereof.
7 The City Council of the City of Las Vegas, Nevada, hereby
8 declares that it would have passed each section, subsection, sub-
9 division, paragraph, sentence, clause, or phrase thereof
10 irrespective of the fact that any one or more sections, subsec-
11 tions, subdivisions, paragraphs, sentences, clauses, or phrases
12 be declared unconstitutional, invalid, or ineffective.

13 SECTION 3: All ordinances or parts of ordinances, sec-
14 tions, subsections, phrases, sentences, clauses or paragraphs
15 contained in the Municipal Code of the City of Las Vegas, Nevada,
16 1983 Edition, in conflict herewith are hereby repealed.
